

#### HISTORY OF THE DEPARTMENT

# "Il faut reculer pour mieus sauter" (one must go back in order to leap better)

The Defence Accounts Department (DAD) has been rendering financial, accounting and auditing services to the Armed Forces and allied establishments for over two and a half centuries.

The Department was renamed as Defence Accounts Department on 1st October, 1951 and the Departmental head was re-designated Controller General of Defence Accounts (CGDA). For more than three decades after independence, the DAD functioned under the administrative control of the Ministry of Finance. It was only after the introduction οf the Integrated Financial Advisor Scheme in the Ministry of Defence in August, 1983 that the Department came under the administrative control of the Ministry of Defence.

As one of the oldest departments under the Government of India, the Defence Accounts Department traces its origin to the Military Pay Masters under the East India Company. In January, 1747 the First Pay Master was appointed for paying the Garrison at Fort William, Calcutta. In 1766, a Commissary General was appointed and in 1788, the designation of the Commissary General was changed to Military Auditor General who exercised control over all military disbursements. When the British Crown started administering India in 1858, Military Accountants General (MAsG) were appointed in the Presidencies of Bengal, Madras and Bombay.

The office of the Accountant General, Military Department, was created in April 1864. In 1865, the Government recognized this position as the Head of the Military Accounts Department. The office of Military Accountant General was reorganized in 1892. The office of the then MAG had 8 sections, viz. the Record, Administration, Audit, Accounts, Estimates, Pay, Foreign claims and the Inspection section.

# **ORGANIZATION AND FUNCTIONS**

Defence Accounts Department, with Controller General of Defence Accounts as its head, functions under the administrative control of the Secretary (Defence/Finance), Ministry of Defence. The important duties of DAD broadly include Internal Audit, Payment and Accounting of all charges pertaining to the Armed Forces, including bills of supplies and services rendered, civil construction and repair works, pay and allowances, miscellaneous charges, pensions, etc. The Department is also responsible for audit of cash and store accounts maintained by the various units formations (including workshops, dockyards and storage depots) in the three Services. The manufacturing accounts of Ordnance Factories and Naval Dockyards and the store accounts of Ordnance Factories are also maintained by the Department. It also maintains accounts relating to projects of Military work Engineering Services (MES). With the introduction of the Integrated Financial Advisor (IFA) system, the Department is also engaged in rendering financial advice to the Services at HQrs, Command and unit/formation level.

## **MANAGEMENT INITIATIVES: 2012-13**



**Pensioners Portal:** This portal will serve as a single window mechanism for Defence Pensioners to know everything about their pension. It is under development and due for launch on DAD Day, 2013. The portal can be accessed at <a href="http://www.dpdopensioners.org">http://www.dpdopensioners.org</a>



**Cash Management Product (CMP):** State Bank of India has offered a customized Cash Management Product (CMP) to DAD for addressing its requirements of uniform e-payments and reconciliation through a secured payment gateway across various offices.



Strengthening of Internal Audit Function: Out dated local and internal audit manuals have been updated. Fresh instructions have been issued for improving audit reporting. Steps have also been taken to restructure internal audit in accordance with the best international practices by giving due emphasis to risk management, optimum utilization of resources and enhanced service delivery to customers.



**Project "SANGAM":** A project to issue Corrigendum PPOs to approximately 18 lakh pre-2006 retired defence pensioners. So far, approximately 6 lakh Corrigendum PPOs have been issued. Further generation of Corrigendum PPOs is under progress.



**Project "SUGAM":** Initiated to replace the existing Office Automation system, the project is operational in Regional PCsDA/CsDA Offices with in-built audit and validation checks. The system is expected to lend the much required transparency in third party payments. ₹82, 285.65 crores has been transmitted electronically to the bank accounts of the beneficiaries.



**Synergy Conference with Ordnance Factory Board :** Two synergy conferences have been organised with Ordnance Factory Board for creating better co-ordination between the two organizations. The conferences have been effective in resolving various issues of mutual interest.



**Training And Development Policy:** Based on the National Training Policy, 2012 issued by the Government of India, Ministry of Personnel, Public Grievances and Pensions the Department has recently promulgated a new DAD Training and Development Policy, 2013.



**Cricket Tournament:** Defence Accounts Sports Control Board organized the 7th All India DAD Cricket Tournament at Dehradun from 4th to 8th March, 2013.



**Trekking:** The 1st All India DAD trek to Yamunotri was organized from 02nd to 07th June, 2013. Fourteen participants from different offices were a part of the trek.

#### PENSION SANCTION AND DISBURSEMENT

The Defence Accounts Department is responsible for sanction and disbursement of defence pension to retired Service Officers, PBORs, Defence Civilians and their families. Defence Pension budget constitutes more than 50% of the total Central Government budget on Pension. The Pension is sanctioned to approximately 72,000 retirees each year. During 2012-13 the total pensioner's strength was

The Pension Complaint Cell of the took some initiatives CGDA office during 2012-13 for effective and time bound redressal of grievances of the Defence pensioners. It brought all the Pension Disbursing Agencies viz DPDOs and all Central Pension Processing Centres (CPPCs) of banks on one platform at Centralized Public Grievance Redress and Monitoring System (CPGRAM) portal url <a href="http://www.pgportal.gov.in">http://www.pgportal.gov.in</a>. The grievances are being taken up online on CPGRAM with these agencies and

also through dedicated e-mail ID wherever necessary. Replies are also furnished to pensioner's through e-mail, if provided. The Pension Complaint Cell has conducted 4 workshops at CGDA office

# LATEST IMPROVEMENT IN PENSION AND DPDOS

The recommendations, of the Committee of Secretaries (CSC-2012) headed by the Cabinet Secretary on improvement in Pension structure, were accepted by the Government of India in January, 2013.

The DPDOs-functioning under the aegis of CDA (PD), Meerut and CDA, Chennai - which form the bedrock of defence pension disbursement, were entrusted with the onerous responsibility of implementing these recommendations, which were to come into

# **DEFENCE PENSION ADALAT**

Conceptualized in 1987, the Defence Pension Adalats have emerged as an effective and popular platform for redressal of grievances of the pensioners. Six Adalats are held at selected stations every year. 118 Pension Adalats have been held so far. These Adalats serve as an interactive

# **NEW PENSION SCHEME (NPS)**

NPS has been fully operationalized for all Defence Civilians and DAD personnel who joined the Central Government Service from 1st January, 2004. At present there are more than 1.03 lakh NPS subscribers with our 37 Principal Accounts Offices (Pr.AOs) and 586 Pay Account Offices (PAOs) across the country.

Pension Adalats were held at Vijayawada, Lucknow, Amritsar, Kangra, Lansdowne and Trivandrum in 2012. In 2013, Pension Adalats have been held at Bikaner, Bhatinda and Belgaum. Out of 5759 cases registered during these Adalats 4382 cases (76%) have been settled. These Adalats since their inception have registered 48,171 cases, out of which 46,600 cases (96.7%) have been settled till date.

### IT INITIATIVES

- ✓ New All India Compilation System: This project aims at providing a real-time compilation of All India receipts and expenditure and is equipped with generating a much wider range of MIS reports.
- ✓ Vishwak: Implemented in various AOs(GE) offices, it has automated the working of these Offices.
- Bhawan: Implemented in various AAOs(BSO) Offices, it has automated the functioning of these Offices.
- Sugam: Implemented in CDA, Chennai and CDA, Jabalpur, it aims at automating the functioning of Regional Controller Offices. Training for Trainers is under process to expand its implementation to other Regional PCsDA/CsDA Offices.
- Nidhi: A Fund Management System, which has been implemented in all 15 DDPs and CDA (Funds).
- Darpan: A Defence Receipts & Payments analysis project that provides MIS about status of allotment and expenditure of Defence Budget.
- Sulekha: Aimed at automating all the activities of PCDA (O), Pune, this project is under development stage.
- Aashraya: A Pension Disbursement system, it has been implemented in all the 63 DPDOs.
- Suvigya: A Pension Enquiry system, it is available to all the defence pensioners on the CGDA website and in DPDOs.
- ✓ **Project "SANGAM":** A project to issue Corrigendum PPOs to approximately 18 lakh pre-2006 retired defence pensioners. So far, approximately 6 lakh Corrigendum PPOs have been issued. Further generation of Corrigendum PPOs is under progress.
- Pension Sanction System: This has automated the pension sanction system in PCDA(P) Allahabad. It has been implemented in PCDA (P) Allahabad. Yet to be implemented in CDA(AF), New Delhi and PCDA(Navy), Mumbai.
- Pension Accounting System: Aimed at automating the accounting function of PCDA(P), Allahabad, the project has been implemented and is undergoing parallel run.
- Pensioners Portal: This portal will serve as a single window mechanism for Defence Pensioners to know everything about their pension. It is under development and due for launch on DAD Day, 2013. # FINANCIAL ADVICE FUNCTIONS

"To conduct the government of a State... there must be religious attention to business and ... economy in expenditure" - Confucius, The Analects (Book1)

The IFA system was progressively introduced in the Ministries following departmentalization of Accounts in 1976. In the Ministry of Defence, the IFA system was introduced first in the Department of Defence Production & Supplies and in the Defence Research & Development Organization in 1976 and later, in the Department of Defence from 1st August, 1983. The Ministry of Defence decided in November, 1991 that delegated financial powers should be exercised

During the year 2012-13, Principal IFAs and IFAs handled 52,897 proposals amounting to ₹18,215.88 crores relating to Acceptance of Necessity and quantity vetting. Further, financial concurrence for 78,442 proposals amounting to ₹18,473.41 Crores was accorded by Principal IFAs/IFAs and savings to the tune of ₹400.61 crores were achieved during the financial year

with the advice of the local Financial Advisors. Accordingly, Integrated Financial Advisors (IFAs) were positioned in the Service HQrs in 1994 and at Director General of Border Roads in 1995. Consequent to enhancement of delegated financial powers to the Services in April, 2002, IFAs were positioned at the Command level. In July, 2006 more powers were delegated to the Services, particularly to authorities at the Command level and below. Consequently, for the first time, dedicated IFAs were posted at Corps HQrs to enable authorities at the Corps and Unit level to exercise such powers.

There are 106 IFAs who provide coverage to the Services at HQrs, Command and unit/formation level. Of these, 85 are dedicated IFAs who are co-located with the Competent Financial Authorities (CFAs), whereas 21 IFAs have been nominated to discharge the function of

During the year 2012-13, 49.18% of Revenue budget of Defence Services under M i n o r H e a d - Transportation, Stores & Other Expenditure (Misc Expenses) was processed through the IFAs.

IFA in addition to their own duties. In order to address and resolve various issues relating to the exercise of delegated financial powers, a meeting of APEX level committee on IFA system was held on 29th November, 2012 at Brar Square, Delhi Cantt.

computerize the functioning of IFA offices. In the first phase, 55 IFA offices have been identified for implementation. The automation covers decision support system, MIS generation and standardization of screens for all the Services.

#### **INTERACTION WITH THE SERVICES**

First quarterly meeting of senior officers of Army HQrs and PIFA/IFAs was held on 27th November, 2012 at South Block, New Delhi to discuss the issues concerning the processing of procurement proposals. The DCOAS (P&S), DCOAS (IS&T), MGO, Pr.IFA (Army-M), IFA (Q) were present on the occasion. The 2nd Quarterly Meeting of all CFAs/IFAs of IHQ of MoD (Army) was held under the chairmanship of the VCOAS on 03rd May, 2013 at AG's conference Hall.

The annual meeting to review the progress of expenditure under Army Commander Special Financial Powers was held at Army HQrs on 15th November, 2012. All Command IFAs (Army) were present on the occasion.

In order to facilitate proper examination of the proposals, a ready reckoner for DPM-2009 duly linked with the amendments/clarifications issued vide Supplement 2010 to DPM-2009 has been prepared and circulated according to the stage of proposal(s) i.e vendor registration, AON, Formulation

of tender enquiry, TPC, financial concurrence, post contractual management etc.



#### SYNERGY CONFERENCE WITH ORDNANCE FACTORY BOARD

The initiative by CGDA to organize synergy conferences has marked the beginning of an understanding between Ordnance Factory Board and Defence Accounts Department. It has led to better co-ordination between the two organizations and is working effectively in resolving various issues of mutual interest.

Two synergy conferences, both cochaired by DGOF and Chairman OFB and CGDA, have been organized so far. The 1st Synergy Conference was held on 22nd January, 2013 at Kolkata. The second conference was held on 18th June, 2013 at CENTRAD, Delhi Cantt. The issues regarding common and integrated database were discussed threadbare and it was decided to reconcile the ground level balances of

the inventory in each Ordnance Factory to begin with. It is in fact, a challenge before the department to build domain expertise for the officers and staff in the specialized area of factory accounts and various policies are being contemplated to bring in specialization in this area. The conferences have created an environment of better understanding and camaraderie between the two services.

#### **INTERNAL AUDIT**

The Defence Accounts Department (DAD) carries out internal audit relating to Army, Navy, Air Force, Ordnance Factories, Border Raods, Coast Guard, CSD and the DRDO. This function is exercised by DAD on behalf of the Secretary (Defence/Finance) who functions in the dual capacity of principal representative of Ministry of Finance in the field of Defence expenditure and as the Chief Accounting Officer for Defence Services.

Internal Audit practice is moving away

from the traditional role of mere assurance audit which takes the form of transaction and compliance audit and reporting control deficiencies to management. Focus is now on providing a cost-effective and useful service. Audits are becoming more useful because they are oriented towards identifying problems, working with management for solving them, providing overall ratings on the adequacy of controls and finding new and better ways of doing things. It is a continuous process.

In the context of the Defence Accounts Department, we have been practicing transaction and compliance audit without specific focus on risk based audit, excepting in a limited manner in few selected areas. Recognising the need to focus on the risk assessment, we have made an attempt to analyse the inherent risks of the auditee organisations based on the significant audit findings. The 32nd Internal Audit Report has (42) Audit Paras with a total approximate financial implication of ₹500 crores.

#### **Strengthening Audit Mechanisms**

The department has been striving to strengthen its internal audit mechanisms and as an initial step has updated Internal Audit



Manual for R&D, Air Force Local Audit Manual and the Canteen Store Audit Manual.

A Seminar on Internal Audit was conducted at Centre Training Development, (CENTRAD), Brar Square, Delhi Cantt on 17th and 18th December.

2012 to discuss the immediate concerns facing the Department in the area of Internal Audit. The topics covered during the various sessions of the seminar included Internal Audit-Role, Mandate and Expectations, Internal Audit-Current Status, Audit of Sanctions, Internal Audit: A Customer Perspective Re-Orienting Internal Audit. A total of twenty two IDAS officers of senior and middle management level from different field offices participated in the seminar.

A conference of Regional PCsDA/CsDA was held at the office of CGDA, Delhi Cantt. on 20th and 21st February, 2013 to discuss the important areas of concern and constraints faced by them in providing efficient service delivery. Nine (9) PCsDA/CsDA from Lucknow, Jammu, Chandigarh, Chennai, Meerut, Patna, Guwahati, Secunderabad and Jabalpur participated in the conference. Concern areas on Monthly Pay System, Financial Management of Works, GPF and Pension Matter, EDP Projects, Post audit of Bills, Strengthening Local Audit, New Pension Scheme, Human Resource Management and CMP-e-payment were discussed. Need was felt for bringing



about improvement in the performance of the PAOs and quality of Local Audit. It was decided to review the progress of implementation of the decisions taken during this conference. The review of the conference of PCsDA/CsDA Conference of Regional PCsDA/CsDA in progress held in February was held on

10th and 11th June, 2013 where in the efforts made on the areas of concern were addressed.



#### ACCOUNTS AND BUDGET

The Department handles all matters related to Budget and Accounts of Ministry of Defence. The total Defence expenditure handled during the financial year 2012-13 is ₹ 2,50,141 crores. Out of which ₹ 1083 crores pertains to Defence Accounts Department. The primary function of the Department is to ensure that the receipts & expenditure pertaining to Defence Services are promptly brought



to account under the appropriate heads. DAD renders advice on all financial and accounting matters to the Executive authorities, Service HQrs and MoD.



#### **PAYMENT FUNCTIONS**

Timely and accurate payment of Pay and Allowances of the Armed Forces and personnel of other Defence establishments is our priority. On an average approximately  $\stackrel{?}{\sim} 65,000$  crores is paid on account of pay and allowances.

As many as 44 PAOs across the country are maintaining the pay accounts of approx 12.8 lacs J C O s / O R s (including Territorial Army personnel) of

Indian Army. Monthly Pay System (MPS) in respect of about 39,000 Territorial Army personnel has also been implemented in the concerned PAOs. The MPS is running successfully in all PAOs and "Project Dolphin" has provided further impetus for prompt adjustment of all DOs II affecting pay and allowances of JCOs/ORs

and also to ensure real time credit/debit in the IRLAs.

During 2012-13, pay and allowances to the tune of ₹36,401 crores were released through the system. All the credit balances which were withheld at the time of implementation of MPS have been released. Directions to the PAOs to deal with TA/DA/LTC claims from 1st April, 2013 have been issued for the convenience of the JCOs/ORs.

- Monitoring through monthly MIS Reports at HQrs level
- Minimizing rejections of DOs II by establishing compatibility of Dolphin with Appx-J/HRMS/ ARPAN
- Regular meetings with AG's branch to discuss problematic areas and find solutions for better customer satisfaction
- Setting up of Help Desk/Jawan Jankari Kaksha for providing salary - related information and grievance redressal



#### **IMPLEMENTING APEX COURT ORDER ON RANK PAY**

The IVth Central Pay Commission (CPC) recommendations fixed the pay of the Service Officers in the new scale on 1st January, 1986 by adding fitment benefit of 20% of the Basic pay in the existing emoluments and deducting the amount of the newly introduced Rank Pay. The Rank Pay for the rank held was paid separately and treated as Basic Pay. Major (Retd) A K Dhanapalan holding the rank of Captain on 1st January, 1986 filed a petition against the deduction of Rank Pay in Kerala High Court at Ernakulam. The High Court gave a ruling in his favour on 5th October, 1998. Finally, the Hon'ble Supreme Court too, in its judgement dated 4th September, 2012, upheld the judgment of the Kerala High Court. The judgement involved the pay revision of officers holding the rank of Captain to

Till mid-September 2013, PCDA (P), Allahabad has issued 9760 PPOs in respect of Army officers. PCDA (Navy), Mumbai and CDA (Air Force), New Delhi too have promptly vetted/pre-audited all the cases submitted to them by NPO Mumbai and AFCAO Delhi Cantt respectively. PPOs in respect of 2259 and 5299 retired personnel were issued by PCDA (Navy), Mumbai and CDA (Air Force), New Delhi respectively.

Brigadier and their equivalent in Navy and Air Force with effect from 1st January, 1986 without deducting rank pay and also subsequent revision for Vth and VIth Pay Commissions.

This entailed, re-fixation of pay for over 44,000 Armed Forces officers and revision of pension of the affected in a time bound manner.

#### **E-PAYMENT**

The Department has been moving towards greater transparency and efficiency in its functioning through e-governance. Various DAD Offices in accordance with the guidelines issued by HQrs office/CVC are making payments through RBI approved electronics platforms such as Electronic Clearing Service (ECS), National Electronic Fund Transfer (NEFT), Real Time Gross Settlement (RTGS) etc. They are also implementing e-payment system through RBI/SBI and a couple of private banks.

In 2012-13, e-payments worth ₹1,35,718.71 crores have been made to the bank accounts of the beneficiaries, thereby bringing transparency in third party payments.

State Bank of India has offered customized Cash Management Product (CMP) as a solution to address the requirements of uniform e-payments and reconciliation, through secured payment gateway, across various DAD offices.

Till date 27 offices have started making payments through the CMP portal.

#### Salient Features Of Cash Management Product (CMP)

- \* CMP Centre to be:
  - one point contact for all defence payments
  - link as well as Focal Point Branch (FPB) for e-payment to the beneficiaries through NECS/NEFT/RTGS etc.
- Hosting of a Secured Web-Portal to work as a Payment Gateway
- \* Payment files, in a prescribed format to be routed by Account Officers to CMP portal
- \* Portal Hosted and User-ID password created for users to upload and authorize the file
- \* Daily updation of paid or unpaid data by CMP to all the Accounts Offices on the portal for online reconciliation of payments to be supported by payment scrolls
- \* Scrolls uploaded on to Portal to carry complete history of the transaction including payment reference number and date of settlement with RBI
- \* Settlement of Fund with RBI CAS Nagpur based on mandate without any physical cheque. Payment to be released to beneficiaries before seeking funds i.e. before debiting defence proforma account with RBI.
- \* Uniform process across the country with a stricter and centrally monitored Turn Around Time (TAT). Payment files to be processed on the same day.



#### **ACCOUNTING FOR THE "BLUE BERETS"**



India is committed to assist the United Nations (UN) in the maintenance of international peace and security. The nation has a proud history of UN peacekeeping dating back to its

inception in the 1950s.

Beginning with the Korean mission, India has participated in

over 35 missions spread across 4 continents and has contributed over 55,000 military/police personnel.

A DAD cell headed by an IDAS officer with supporting complement is positioned with the Indian Army contingents deployed in these UN peace keeping operations. Contingents deployed on these missions

are required to carry equipment, vehicles, arms, ammunition and additional stores with them from India. The UN reimburses t h e government for the personnel/equipments provided in the Mission Area. Currently there are five ongoing missions deployed with Indian



#### DAD AND UN

PCDA. New Delhi serves as the nodal office for all UN Missions and performs the following functions:

- Monitoring of receipt of reimbursements from UN missions for troop and ammunition cost, usage of equipment/arms etc
- Disbursement of Overseas Allowance (OSA) to Indian Troops deployed in UN peacekeeping missions
- Disbursement of advances for imprest and National Day celebrations
- Payment of compensation to contingent member/next of kin of the deceased member of Indian contingents on receipt of the same from UN

#### **HUMAN RESOURCES MANAGEMENT**

The Department has witnessed erosion in its strength over the years. As against the authorized manpower of over 30,164 as on 01st January, 2013, the present strength is around 19,746.

Officers of the Indian Defence Accounts Service (IDAS) constitute the Group 'A' cadre. The current authorized strength of the IDAS officers is 656 including Probationers/Deputation/Leave and Training Reserve. The number of IDAS probationers joining the Department has increased during the past few years.

The Group 'B' Cadre which constitutes twenty percent of the total manpower of the Department comprises of Senior Accounts Officers (SAOs), Accounts Officers (AOs) and the Assistant Accounts Officers (AAOs). Other than these, Group 'B' Gazetted posts in the rank of Hindi Officer and Senior Personal Secretary / Personal Secretary are also there. The SAOs, AOs and AAOs are inter alia entrusted with guiding and supervising the work done by the Sr. Auditors/Auditors/Clerks.

75% of the manpower in the department is constituted by Group 'C' staff, most of whom are Senior Auditors, Auditors and Clerks recruited through examinations conducted by the Staff Selection Commission. This segment forms the core of our work force.



The All India DAD Quiz

The ban on recruitment and provisions of Annual Direct Recruitment Plan has resulted in non-filling of critical vacancies. The posted strength of Auditors/Clerks has been brought down to 12,715 as on 1st January, 2013. In the year 2013-14, 2610 vacancies have been released for the post of Auditors. In addition the department will be receiving 1625 dossiers against 6000 vacancies released earlier.

#### TRAINING OF OFFICERS AND STAFF

The Department endeavours to live up to its motto of: "In the Service of the Services" by regularly assessing the competency gaps in its



workforce and provides the requisite training to bridge these gaps through its Regional Training Centres (RTCs) at Meerut, Lucknow, Bengaluru, Kolkata, Pune and Gurgaon and the National Academy of Defence Financial

Management (NADFM), Pune. The Department also has a dedicated Defence Pension Training Institute (DPTI) located at Allahabad.

Based on the National Training Policy, 2012 issued by the Government of India, Ministry of Personnel, Public Grievances and

Pensions the Department has recently promulgated a new DAD Training and Development Policy, 2013.

An important feature of this new policy is the introduction of a foundation course for the newly recruited auditors and clerks. The course has been structured to instill and imbue in them a sense of pride in the department and the high values for which the department stands.

#### **INTERFACE WITH OTHER PREMIER INSTITUTES**

IDAS officers are deputed on long- term training courses at the National Defence College (NDC) and the Indian Institute of Public Administration (IIPA) every year. Our officers regularly attend courses at the Royal Institute of Public Administration (RIPA), London which enables them to learn the best accounting and management practices from around the world. 3 lady officers attended the course at RIPA this year.



#### **DEFENCE FINANCIAL MANAGEMENT COURSES (DFMC)**

## Post Audit of ECHS Paid Vouchers-Streamlining of ECHS through post audit of ECHS expenditure

- The ECHS (Ex-servicemen Contributory Health Scheme) was introduced on 1st April, 2003. The responsibility of post audit of ECHS expenditure rests with Regional PCsDA
- The office of PCDA(WC), Chandigarh receives approximately 2,64,000 paid vouchers of ECHS for post audit annually, for which there is no separate authorization of manpower. Lack of requisite skills for specialized nature of audit, space constraints etc. are the other major hurdles



- ✓ The team through its dedicated and diligent efforts scanned the vouchers working backwards and gradually focused on the audit of high value vouchers and brought the work to the current status by June, 2013
- ✓ The special drive has a ripple effect, in that, it opens the doors for similar efforts by other PCsDA/CsDA in fulfillment of the mandate regarding better financial management of the ECHS


