The following facts brought out with regard to transfer of Smt. Sandita Aditya, AAO/8333962 has been noted by the DAPB.

1. At present, Smt. Sandita Aditya, AAO is serving in PCDA (P) Allahabad since 25.07.2011.





The following facts brought out in the request forwarded by Sh. A. Ramaiah, IDAS vide DO. letter dated 19.05.2015, has been noted by the DAPB: -

1. Their office is facing acute shortage of AAOs as on date, out of Total sanctioned strength of 19 AAOs, only 14 AAOs are posted.
2. This shortage will further aggravate due to retirement of 3 AAOs in the month of May, June, September respectively and after relieving of 3 AAOs, who are under transfer including Sh. B. Satyanarayana Murthy AAO.
3. Among the remaining volunteers of HYL 10/2014 for Sec^{bad}/Hyderabad, there are 04 Volunteers (Namely, K Naganathan, P N Sarma, C V Nataraj and T R Sanjay) have given their choice as Hyderabad/Sec^{bad}.
4. The DAPB has examined the case and recommends that 4 AAOs as per Para '3' may be posted to CDA (R&D)Hyderabad (Sl.No. 01 is under the zone of promotion to the grade of AO's and Sl.No. 04 has withdrawn his name). However, CDA (R&D) may also be advised to relieve the AAOs who are under transfer to other station immediately.

1. Shri K. Narayanan, AAO serving in the office of the AO (CF) has requested for consideration of his transfer from Aruvankadu to Avadi/Chennai on the grounds of spouse illness.

2. On perusal of his case file, DAPB has observed that earlier he was considered for transfer to Pune under the organization of PCDA (SC) Pune during the finalization of HYR 10/12 transfers in the month of April 2013 on the basis of station seniority of Avadi station along with other similarly placed officers.

3. After issuance of transfer order by HQrs. office he had represented his case for cancellation of transfer order on the same grounds but his request was not acceded to. Thereafter he had taken an interview in HQrs. office with the competent authority and explain his family position and requested for change of place of posting from Pune to Aruvankadu. 4. Further, the officer has not submitted current medical paper/certificate in support of his wife's illness.

Keeping in view of the findings as stated above, DAPB did not find it feasible to consider his request for change of place of posting from Aruvankadu to Avadi in view of the Paras above.
