**Subject:** Promotion of Accounts Officer to the grade of Senior Accounts Officer: Vacancy year 2012-13.

**Reference:** HQrs office promotion order No. AN/II/2167/2012-13, dated 28.03.2012 and order dated 16.10.2012.

Please refer to the HQrs Office above cited promotion order dated 28.03.2012 and dated 16.10.2012 (copies enclosed) under which 471 and 02 Accounts Officers respectively were promoted to the grade of Senior Accounts Officer with effect from 01.01.2012. The DOP&T O.M No. 22011/3/98-Estt. (D), dated 14.08.2003 stipulates that eligibility as on the crucial date of 1<sup>st</sup> January is to be checked only in respect of those officers in the feeder grade who are not due for retirement before the date of commencement of the relevant financial year based vacancy year i.e. 1<sup>st</sup> April. Accordingly, the DPC considered only those Accounts Officers who were in service as on the date of commencement of the financial year based vacancy year i.e. 01.04.2012 and the officers who were due for retirement between 01.01.2012 to 31.03.2012 were not considered by the DPC for promotion to the grade of Senior Accounts Officer against the vacancy year 2012-13. However, the competent authority, at the time of approval of the recommendation of the DPC, approved to promote the Accounts Officers to the grade of Senior Accounts Officer against the vacancy year 2012-13 w.e.f 01.01.2012 after considering representations of some Accounts Officers.

2. The competent authority had also approved that a Review DPC for the officers who were retired/taken VRS/expired between 01.01.2012 to 31.03.2012 be convened to consider them for promotion to the grade of Senior Accounts Officer w.e.f. 01.01.2012 against the vacancy year 2012-13. However, the Review DPC raised objection on considering the officers for promotion to the grade of Senior Accounts Officer who were not in service as on commencement of the financial based vacancy year i.e. 01.04.2012 as per DOP&T O.M dated 14.08.2003. Therefore, the matter was subsequently referred to DOP&T for clarification regarding grant of promotion with effect from 01<sup>st</sup> January in view of the provision contained in DOP&T O.M No. 22011/3/98-Estt. (D), dated 14.08.2003.

3. It has been clarified by the DOP&T that promotion of the officers included in the panel for the year 2012-13 with effect from 01.01.2012 was not in order and has therefore

directed the Department to take the remedial action to revise the date of promotion of all the officers promoted against the vacancy year 2012-13 with effect from 01.04.2012 or from the assumption of charge whichever is later.

4. In view of the above, the Competent Authority has decided to revise the date of promotion of the Accounts Officers who were promoted to the grade of Senior Accounts Officer vide HQrs office promotion order dated 28.03.2012 and 16.10.2012 from 01.01.2012 to 01.04.2012 or from the date of assumption of charge whichever is later. The revised Part-II Office Order notifying the said promotion w.e.f 01.04.2012 or from the assumption of charge whichever is later may please be sent to the HQrs office for record.

5. Accordingly, the following consequential actions may also be initiated at the earliest:

- (a) The pay in respect of the officers who are still in service (list enclosed as **Annexure-'A'**) may please be re-fixed and accordingly overpayment due to re-fixation of pay may please be recovered from the officers concerned and a confirmation in this regard may be furnished to the HQrs office.
- (b) The pay in respect of the officers who have since retired from service (list enclosed as **Annexure-'B'**) may please be re-fixed. Necessary action for issue of corrigendum PPO may also be initiated. Overpayment arising due to re-fixation may be recovered from any terminal benefits due to the pensioners. The amount of overpayment may please be computed and intimated to HQrs Office in each case separately for further necessary action in the matter.

6. An action taken report in this regard may be sent to the HQrs Office by 15<sup>th</sup> September, 2015.
