**Subject:** Promotion of Accounts Officers to the grade of Sr. AO.

The Competent Authority has approved promotion of 07 (Seven) Accounts Officers to the grade of Senior Accounts Officers as per **Annexure-I** to this letter, carrying Pay Band-3 ₹ 15600-39100 with Grade pay ₹5400/- [₹ 8000-13500 (pre-revised)] with effect from **01<sup>st</sup> May, 2016** or from the assumption of charge whichever is later. The promotion of Accounts Officers who are presently on deputation will be treated as proforma promotion under NBR.

2. Before promoting the AOs, it may please be ensured that none of the circumstances enumerated in para 2 of the DOP&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 have arisen before promotion. If such circumstances have arisen the promotion shall not be released and instead considered as if, the case of the officer concerned has been placed in Sealed Cover by the Departmental Promotion Committee, in terms of para 7 of the ibid OM. It may also be ensured that any Accounts Officer, undergoing penalty, such as stoppage of increment/reduction of pay on the due date of promotion, is not promoted till the expiry of the penalty period.

3. The Part-II Office Order notifying the promotion interalia indicating the authority may be endorsed to this HQrs. Office. The Part-II Office Order in respect of officers serving in IFAs may be published by the respective proforma Controllers. In cases where transfer orders have been issued recently by this Hqrs., new offices have been shown in the Annexure, however, the part II O.O may be notified by the Controller on whose strength the officer is actually serving as on date if not relieved, otherwise by the new Controller in consultation with previous Controller.
