Promotion to the Senior Time Scale (Group 'A') of the Indian Defence Accounts Service on Ad hoc basis.

The thirty five (35) officers serving in the offices/Organizations indicated against each in the Annexure to this letter have been selected for promotion from Junior Time Scale (Scale of Pay Rs. 15600 - 39100 + Grade Pay Rs. 5400/-) to the Senior Time Scale (Scale of Pay Rs. 15600 - 39100 + Grade Pay Rs. 6600/-) of the Indian Defence Accounts Service on an adhoc basis with effect from 01.01.2011 or from the date of assumption of charge in STS whichever is later.
