

SUB: Observance of Vigilance Awareness Period - 2010.

  - · To issue special journals during the period; and
  - To request the non-government organizations, institution and service associations in the local area to participate in the Vigilance Awareness campaign.
  - · To have a dedicated toll-free hotline number to receive complaints against corruption.
