
**SUBJECT: IMPLEMENTATION OF THE GOVERNMENT DECISION ON THE RECOMMENDATIONS OF THE SIXTH CENTRAL PAY COMMISSION – REVISION OF PENSION OF PRE-1.1.2006 MILITARY NURSING SERVICE (MNS) OFFICERS RETIREE PENSIONERS/FAMILY PENSIONERS.**

Sir,

The undersigned is directed to refer to this Ministry's letter No. 17(4)/2008(1)/D(Pen/Policy) dated 11.11.2008 on the above subject as amended vide this Ministry's letter of even No. dated 20.1.2009 and to state that as per the provisions of Para 5 of this Ministry's above mentioned letter dated 11.11.2008, the amount of minimum guaranteed pension and ordinary family pension in respect of commissioned officers of Military Nursing Service(MNS) was not included in the Annexure-II to this Ministry's above quoted letter dated 11.11.2008 as amended, due to non issuance of revised pay structure for MNS officers under Sixth CPC at that time. The revised pay structure for them has since been issued vide Special Army Instruction 4/S/2008. Accordingly, a table showing rates of minimum guaranteed pension and ordinary family pension for Pre-1.1.2006 MNS retiree officers is enclosed to this letter which may be treated as **Annexure-II A** to this Ministry's above quoted letter dated 11.11.2008.

2. This issues with the concurrence of the Finance Division of this Ministry vide their UO No. 1632/09/D(Fin/Pen) dated 5.5.2009.

**NOTES:**

1. The pension of Pre-1.1.2006 pensioners is required to be first revised by Pension Disbursing Agencies in terms of Annexure-1 read with Para 4 of GOI MOD letter No.17(4)/2008(2)/D(Pen/Policy) dated 11.11.2008. However, in case the pension so consolidated happens to be less than the amount indicated in the Table above, the pension protection as indicated in this Table will be given.
2. Rates of Pension at Table -1 above have been shown for qualifying service of 10 years and above as MNS officers are entitled for invalid pension after 10 years of qualifying service.
3. In order to cover all conceivable situation, revised pension with as low as 10 years qualifying service has been shown in this Table even for such senior ranks as Maj. Gen./Brigadier even though such cases may not occur in reality.
4. While the qualifying service indicated in Table - 1 above is the actual qualifying service, the amount of pension indicated is inclusive of the rank weightage as admissible in terms of Para 5.1 (b) (ii) of this Ministry's letter No. 1(6)/98/D(Pen/Services) dated 3.2.1998.

**Explanatory Note:**

As a result of the difference in weightage allowable to different ranks, the pro-rata pension in earlier cases in certain lower ranks is more as compared to higher ranks with same qualifying service.
