Subject: Amendment to DFPDS 2016

Ref: (i) Delegation of Financial Powers in MOD- 2015 (DFPM-2015)
(ii) Delegation of Financial Powers to Defence Services – 2016 (DFPDS-2016)

As per DFPDS 2016 para 4 the powers for PAC and Single Tendering Cases are 50% and 5% respectively of the powers for competitive bidding cases mentioned in each sub-schedule of DFPDS/DFPM. This provision has been reviewed and it has been decided that henceforth the powers for PAC tendering would be 100% of the competitive bidding powers in each sub-schedule and powers for Single Tendering cases would be 50% of the competitive bidding powers in each sub-schedule.

2. This has the concurrence of Financial Adviser (DS) and approval of Raksha Mantri.
