Sub: Communication of Sanction in case where Competent Financial Authority (CFA) approves a proposal by overruling the concerned Financial Adviser.

References have been received relating to Communication of Sanctions as to how the fact of consultation/concurrence of CFAs/IFAs is to be incorporated in a sanction. The formulation to be used both in the event of approval by CFA with the consultation/concurrence of IFA as well as in the event of approval a proposal by overruling the concerned IFA has been examined and **it is clarified that the following formulation may be adopted while communicating sanctions to Audit**


2. a. Communication of sanction when the proposal is approved by Competent Financial Authority (CFA) with the consultation/concurrence of concerned IFA

Dated"***

(b) Communication of sanction where the proposal is approved by Competent Financial Authority (CFA) by overruling the concerned Financial Adviser


