SUBJECT: - ENHANCEMENT OF EXISTING DELEGATION OF FINANCIAL POWERS FOR SANCTION OF CAPITAL ACQUISITION PROPOSALS COVERED BY THE SERVICES CAPITAL ANNUAL ACQUISITION PLANS.

A copy of MoD (Fin) ID No. 14(23)/2003/IFDP II dated 27 September 2010 for enhancement of existing delegation of financial powers for sanction of capital acquisition proposals covered by the Services Capital Annual Acquisition Plans on the above subject is enclosed herewith for information and necessary action please.

The ibid order clarifies that:-

- (b) The enhanced powers do not apply to the Boarder Roads Organization;
- (c) For the Dept. of Defence Production, the enhanced powers shall apply to the the projects and schemes, which may include purchase of machinery & equipment, land and works;
- (d) For the Department of Defence Research & development, the enhanced delegation shall apply to projects and schemes, which may include machinery & equipment, land and works, as also a revenue element.

Subject: Enhancement of existing delegation of financial powers for sanction of capital acquisition proposals covered by the Services Capital Annual Acquisition Plans

Reference: MoD (Fin) ID No 14(23)/2003/IFDP II dated 30th July 2010

The Ministry of Finance has been returning several proposals of this Ministry, relating to land and works etc. stating that the Ministry should consider dealing with those proposals under the enhanced delegated powers. The matter has been examined and it has been decided with the approval of the Raksha Mantri to clarify that:

- The enhanced powers apply to the capital acquisition cases of the three Services and HQ IDS included in the Service Capital Acquisition Annual Plan, as also capital acquisition cases of the Coast Guard;
- The enhanced powers do not apply to the Border Roads Organization;
- For the Department of Defence Production, the enhanced powers shall apply to the projects and schemes, which may include purchase of machinery & equipment, land and works;
- For the Department of Defence Research & Development, the enhanced delegation shall apply to projects and schemes, which may include machinery & equipment, land and works, as also a revenue element.

2. The proposals returned by the Ministry of Finance may also be processed accordingly.
