Minutes of the 19th Meeting of DASCB

The Board met at 11.00 A.M. on Wednesday, the 24th Feb, 2016 in HQs Office, Delhi and the following were present.

At the outset of the meeting Secretary, DASCB welcomed the Chair and all the members of the Board and gave a brief presentation on DASCB.

2. Thereafter Board took up the Agenda points for discussion

Point No. 1: Confirmation of the Minutes of the 18th Meeting of DASCB

The Board confirmed the minutes of the 18th Meeting of DASCB.

Point No. 2: Action taken on the decisions of the 18th Meeting of DASCB

- ➤ Point No. 7 of 18th Meeting: More Intra DAD staff tournaments:
 - 02 tournaments organized at Zonal Level
 - 1. Inter Controller Table Tennis & Carrom Tournament at Delhi.
 - 2. Inter Office Cricket Tournament at Pune.
 - DASCB Cricket Team participated in the outside Tournaments.
- ➤ Point No. 8 of 18th Meeting: Distribution of players amongst Controllers during tournaments:
 - Sports quota players were distributed amongst Controller's office during the AIDAD Volley Ball Tournament held at Lucknow.
- ➤ Point No. 9 of 18th Meeting: Sports Calendar approved
 - 02 tournaments out of 04 were organized at All India Level:
 - 8th AIDAD Table Tennis Tournament at Pune.
 - 5th AIDAD Volley Ball Tournament at Lucknow.

3. Agenda Points were discussed and the following decisions were arrived at:

- i. Affiliation to various sports federations/bodies of Central Level or State Level may be expanded to include games like Cricket, Hockey, Volley ball and Basket ball and got obtained. Separate approval for each sports federation may be obtained from the Chairperson, DASCB.
- ii. CGDA noted that there is lack of direction and mismatch between number of recruits according to the sports disciplines/streams and tournaments participated. A clear direction should emerge. Players for DASCB team for each stream of sports having sports quota recruits to be identified. Detailed methodology and procedure for selection of the teams be prescribed and proposal in this regard needs to be submitted urgently.

- iii. After selection of the DASCB teams Coaching camps of two week duration should be organised for the sports like Cricket, Football, Volleyball, Hockey, Badminton, Table Tennis, Carrom and Chess. For this purpose, Coaches approved by SAI i.e., Sports Authority of India or Equivalent bodies should be selected.
- iv. Broad procedure and guidelines on recruitment of eminent Sports personalities and sports quota persons in the DAD may be got approved within one month. Then, procedure may be initiated by Administration for fulfillment of available vacancies under sports quota. In respect of recruitment of eminent Sports personalities through talent scouting as being done by Railways, their recruitment level, promotions etc may also be examined.
- v. A proposal to increase annual grant to DASCB from Rs. 12 lakh to Rs. 25 lakh may be initiated. A statement of case for this purpose may be formulated with adequate justification.
- vi. Matter of giving 15% of Quantitative Discount to DASCB instead of Army Sports Development Fund may be examined in the backdrop of existing guidelines of MOD.
- vii. A prominent link to webpage of DASCB may be given on homepage of the CGDA Website. More write-ups should be provided. Positions and vacancies should be displayed to attract best talent.
- viii. Feasibility of getting grants for construction of multi-purpose hall in various CDA/PCDA offices from Ministry of Youth Affairs & Sports may be

examined. Database of sports infrastructure in DAD premises may also be compiled.

- ix. Jurisdiction of Regional members of DASCB will be defined and intimated to the respective members.
- x. Annual Sports Calendar for year 2016-17 should be submitted for approval of the Chairperson, DASCB. Hockey and Volleyball tournaments may also be added to the proposed sports calendar. Chess Tournament will be conducted by CDA, Chennai while Cricket tournament will be conducted by PCDA (SC), Pune. Carrom tournament will be held at CDA, Patna. (Tournaments for women officials will also be included).
- xi. As suggested by PCDA (CC), a course on training of yoga trainers will be conducted at RTC, Lucknow in first quarter of the financial year 2016-17.
- xii. As suggested by PCDA (SC), posting of sports quota personnel to their choice place of posting will be considered by Administration for the period of 3-5 years. The players will show their performance and participate at the National level tournaments in the respective sports. Placement of sports quota personnel may be reviewed after 3-5 years.
- xiii. CGDA noted with concern that meetings of DASCB are not being held regularly. One meeting in half year as prescribed in MOU should be held. Accordingly, it was decided that the next meeting of DASCB will be held in last week of July 2016.
