**Sub: 11<sup>th</sup> AIDAD Badminton Tournament (Men & Women) organised by PCDA(A) Lucknow & IFA(CC) Lucknow.**

The Competent Authority has approved for holding the 11<sup>th</sup> All India DAD Badminton Tournament (Men and Women) in Lucknow.

2. The tournament will be organized for sports quota players and non sports quota players consisting of the following events:-

(i) Men (Singles), (ii) Men (Doubles), (iii) Women (Singles), (iv) Women (Doubles), (v) Mixed Doubles.

3. All PCsDA/CsDA Offices may kindly select 3 Men and 2 Women players from their organization for participation in the tournament. No manager/extra players are allowed to accompany.

4. As decided in the 24<sup>th</sup> Annual Meeting of DASCB, there will be a separate team/entries of IDAS Officers in the tournaments which are organized by DASCB. It is therefore requested that the willing IDAS officers may send their names/entries to PCDA(A) Lucknow & IFA(CC) Lucknow through their Proforma controllers.

5. Players from all Pr. IFA/IFA Offices will be considered as part of the proforma controllers to whom they are attached. They will therefore take part in the internal matches conducted by the respective PCsDA/CsDA organization for their selection .


6. All Badminton sports quota players will have direct entry in the Tournament apart from above players. However they may send their willingness through their Controller/Proforma Controller.

6. All matches will be played in accordance with laws of badminton approved by Badminton Association of India.

7. All PCDA/CDA may submit the particulars of the selected players as per proforma given below to PCDA(A) Lucknow & IFA(CC) Lucknow by 24th January 2025 to enable their office to make further arrangements.
