Subject: Usage of Category Prefix Codes - SFC- Joint Staff.

On review of printed compilation, it has been noticed that Category Prefix Codes as per Annexure- 'B' & 'C' to Classification Hand Book are either used incorrectly or not at all used/prefixed to the relevant service heads. As per Annexure 'C' to Classification Hand Book (2007 Edition), apart from other category codes, Category prefix Codes '33', '36', '37' & '38' have been allotted for DIPAC Project, HQ IDS, Defence Intelligence Agency and SFC respectively for the purpose of segregation of expenditure. HQrs SFC have specifically pointed out that due to non-prefixing of category code '38' to the relevant service heads by the paying Controllers they are facing difficulty in segregating and monitoring the expenditure. Action therefore needs to be taken to ensure that category '38' is properly prefixed to the relevant service heads relating to expenditure on SFC for monitoring of expenditure by the authorities concerned.

Since the category prefixes are based on user's requirement, intended to know distinctively the bookings relating to a specific project/Dte/Command/Organisation etc. and the source of procurement of stores etc., incorrect usage/non-utilization of the category prefix codes defeats the very purpose for which the same have been allotted. Proper usage of category prefix codes therefore needs to be ensured while booking the expenditure. This office in various earlier communications has been emphasizing the need to ensure correct usage of category prefix codes. In this regard this office letter Nos. A/B/I/13626/CHB dated 13th Dec, 2005 & A/B/II/11244/Mont-Army/Vol-V dated 8th Feb 2007 may please be referred (copies enclosed).

It is therefore reiterated that necessary instructions may please be issued to the sections/sub-offices under your jurisdiction to ensure proper usage of category prefix codes to enable the user departments to segregate and monitor the expenditure properly.

Subject: Operation of Redundant/Wrong Category prefix codes with Service Heads

In order to verify the correctness of Category Codes being prefixed to various Service heads, a review of compilation upto the month of December, 2007 has been carried out in the HQrs office. It is noticed that in certain cases the defunct category prefixes are still being operated by some of the PCsDA/CsDA offices. A list showing the code heads against which the obsolete category prefixes have been operated is enclosed for ready reference.

In the above context your attention is invited to this HQrs important circular bearing No. A/B/I/13626/CHB dated 13th Dec. 2005 under which lists of category prefix codes that have been deleted and those which are operational, were circulated to all the Controller's offices for implementation. It is however, evident from the above that due care is not being exercised while operating category prefixes by the dealing staff. Since the category prefixes are based on user's requirements, intended to know distinctively the bookings relating to a specific project/Dte/Command etc. and the source of procurement of stores etc., the incorrect usage of the same defeats the very purpose for which these were intended for. The usage of redundant/superfluous category prefixes to the Service heads results in wrong depiction of expenditure under a particular

Directorate/project and the executive authorities can not make any use of such information.

It is therefore, requested that position may please be reviewed and necessary action taken to rectify the obsolete cat. prefixes in the current month's accounts. Instructions in this regard may please be issued to all concerned sections in the main office and sub-offices under your payment jurisdiction to ensure correct usage of the category prefix codes in future, as circulated vide this HQrs circular cited above.

A compliance report in the matter may please be sent to this HQrs urgently.

Subject:Review of Category Prefix Codes - Classification Hand Book (D5) 1992 Edn.

The Category Prefix Codes to certain Service heads in the CHB were allotted based on the users requirements and were meant to identify separately the expenditure booked on particular project/scheme/item etc. With the passage of time many of these category prefixes were found to have become redundant on opening of separate code heads for the purpose. It was also noticed that there was overlap between various category prefixes after the notification of Command wise category prefixes meant for identification of expenditure pertaining to each Command of the Army, Navy and Air Force, especially for locally controlled heads.

- 2. A detailed review of all the category prefixes in the CHB (1992 Edn) also revealed that there are many cases of incorrect usage of category prefixes occurring year after year. Certain category prefixes are found to have been used with the Service heads other than those for wich the same were meant for Moreover Overlap with command wise category prefixes did not allow for compilation of expenditure in line with DSE Vol-II.
- 3. With a view to remedy the redundancy and overlap of category prefixes it has been decided in consultation with Service HQrs to delete the following category prefixes (25 in numbers) in the Classification Hand Book (1992 Edn) with immediate effect:

The compliance may please be watched at your end so that there are no cases of incorrect usage of category prefixes.

- 5. In order to ensure that correct data on compiled actuals is generated for user requirements for monitoring the progress of expenditure and also for budget forecasts, it is of paramount importance that the category prefixes are used correctly with the relevant Service heads. A list of category prefixes (57 in numbers) that have been retained and would be currently in use is shown in 'Annexure A' (attached). The same may please be circulated to all the sections/sub offices under your jurisdiction duly instructing the dealing staff to ensure correct usage of these category prefixes.
- 6. The category prefixes would also be found incorporated appropriately in the revised edition of the Classification Hand Book which is at the final stages.
