A Committee was constituted to review the permissible period for transfer of funds to Government account in case of e-payment and other related issues. The Committee recommended that the remittance norm of T+1 working day (including put through date) for e-payment as applicable for Private Sector Banks may also be made

Based on the recommendations of the Committee, it has now been decided that in supersession of this office OM No. S-11012/3/P.Intt(RP)/CGA/2007/RBD/1058 \$78 dated 8.7 2008, the remittance period in respect of all Government transactions made through e-payments in respect of Public Sector Banks will be T+1 working day (including put through date) w.e.f. 01.11.2010.
