Considering the above, in cases where there is difference of opinion between the Panel of Offiers and the CFA, the decision of the CFA with or without consultation with IFA, as applicable, would be final. However, CFA will clearly endorse reasons for overruling the recommendations of the Panel of Officers.

CONCLUSION OF CONTRACT - DIFFERENCE OF OPINION BETWEEN PANEL OF OFFICERS AND CFA

- 1. Case for conclusion of contract for procurement of Broiler Alive at Sup Pt Birdhwal and del at Lakhor Chotti and Macchran Wali Johri was recommended by the Panel of Offrs and it was recommended for retender by Intermediary CFA, ie the GOC-in-C, South Western Comd and CFA ie the QMG. As per provn of Para 73 of Govt of India, MoD letter No. PC/RAKSHA/63060/Q/ST5/3633/D(QS) dt 26 Sep 2006, the case was referred to MoD being the next higher CFA.
- 2. MoD has directed that in such cases as in Para 1 above, the provns of DPM-2009 should be followed wherein there is no provn of consideration by the higher CFA. Therefore, decision of the CFA be treated as final.
- 3. Considering the above, in cases where there is a difference of opinion between the Panel of Offrs and the CFA, the decision of the CFA with or without consultation with IFA, as applicable, would be final. However, CFA will clearly endorse reasons for over ruling the decision of the Panel of Offrs.
