Subject: Supplementary DPC for promotion of AAOs to the grade of Accounts Officer against the vacancy year 2019.

Reference : HQrs Office circular No. AN/II/2151/DPC/AAO to AO /2018 & 2019 dated 02.08.2018

Please refer to HQrs Office circular under reference wherein PCsDA/CsDA were requested to forward APARs / MTPARs along with related documents in respect of AAOs (up to Roster No. 850 in r/o Unreserved category AAOs and up to Roster No. 1600 in r/o Reserved Category) for the AAO to AO promotion DPCs against the vacancy year 2018 and 2019.

2. A proposal to convene a Supplementary DPC for promotion of eligible Assistant Accounts Officer to the grade of Accounts Officer against the vacancy year 2019 is under consideration in this HQrs office. Accordingly, it is requested to look into all the cases of reserved category (SC & ST) AAOs up to Roster No. 2100 (including those posted with PIFAs/IFAs who are borne on the strength of the PCsDA / CsDA) and forward their APAR dossiers and other connected documents/ certificates (i.e APAR dossiers containing APARs / MTPARs for the period **2012-13 to 2016-17** and enclosures **Annexure 'A' to 'H'**), as per the guidelines and instruction contained in this HQrs Office circular under reference, to this HQrs. Office, latest by **12. 07. 2019**.

3. It is requested that while forwarding the dossiers and DPC related documents it may be ensured that dossiers / documents are forwarded strictly as per the instructions contained in **Annexure- 1 & 2** of this HQrs Office circular under reference. PCsDA/CsDA are also requested to recheck the APAR dossiers of cases which were forwarded earlier (i.e up to Roster No. 850 in r/o UR and up to Roster No. 1600 in respect of SC/ST AAOs) and if any of the APARs/APARs in respect of

such AAOs are still with them, the same may also be forwarded to this HQrs Office at the earliest.

4. Further, PCsDA /CsDA are also requested to keep ready the APAR dossiers of AAOs (up to Roster No. 1200 in r/o UR category and up to Roster 2500 in r/o reserved category) for the DPC-2020. A separate circular in this regard will be issued shortly.
