Promotion of Assistant Accounts Officers to the grade of Senior Accounts Officer (Group-A).

The Competent Authority has approved promotion of 128 (One Hundred Twenty Eight) Assistant Accounts Officers to the grade of Senior Accounts Officer (Group-A) as per Annexure-I to this letter, in the level-10 (Rs. 56100-177500) of 7th CPC Pay Matrix with immediate effect or from the date of assumption of charge of the promotional post, whichever is later. The officers will be on probation for a period of 02(two) years.

- Before promoting the Assistant Accounts Officers in the grade of Senior Accounts Officer, it may please be ensured that none of the circumstances enumerated in Para-2 of the DoP&T O.M. No. 22011/4/91-Estt. (A), dated 14.09.1992 has arisen before promotion. If such circumstances have arisen the promotion shall not be released and instead considered as if, the case of the officer concerned has been placed in Sealed Cover by the Departmental Promotion Committee, in terms of Para-7 of DoP&T ibid O.M. It may also be ensured that any of the Assistant Accounts Officer, undergoing penalty, such as stoppage of increment/reduction of pay on the due date of promotion etc, is not to be promoted till the expiry of the penalty period. If any such case comes to notice before promotion of the officer, the same may please be intimated to HQrs office immediately.
- 3. Further, it is also stated that in pursuance of DoP&T O.M. No. 36012/11/2016-Estt. (Res-I) (Pt.II), dated 15.06.2018, the above promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court of India in Special Leave Petition (C) No. 28306/2017, SLP (C) No. 30621/2011, SLP (C) No. 31288/2017 (connected to SLP (C) No. 28306/2017) and other related court cases.
- The Part-II Office Order regarding relieving and assumption of charge of the promotional post may please be notified through TULIP and endorsed to this HQrs Office (Admin.-II Section).
- After promoting the officer, Immovable Property Return (IPR) of the officer, as on date of promotion to the Senior Accounts Officer's grade, duly verified, may also be forwarded within 15 days from the date of assumption of the promotion post.

- 6. All the completed APARs/MTPARs in respect of the officers which have become due after the APAR dossier of the AAOs was sent to HQrs Office for DPC, may also please be forwarded to AN-II Section of this HQrs Office immediately, after relieving/promoting the officer.
- Annexure-I. The relief of the officer shall not be deferred on the ground that a representation has been submitted for change of place/office of posting or on the ground that reliever has not been reported / posted. It may be brought to the notice of the officer that no representation for change of posting etc. will be entertained in any case as all efforts have been made to accommodate the individual at choice stations keeping in view of the ground cited in their application to the extent possible and as per administrative feasibility/requirement. PCsDA/CsDA/PIFAs/IFAs may also please ensure that representations are not unduly forwarded to HQrs Office.
- 8. It may also please be brought to the notice of all concerned that non-assumption of charge of the higher promotional post within the period as specified in DoP&T O.M. No. 20034/5/2002-Estt. (D), dated 04.08.2004 would result in invalidation of his/her promotion order and he/she will require to be considered afresh by the next DPC held in normal course. Accordingly, his/her seniority on subsequent promotion will be as per the position in the fresh panel.
- TA and Joining Time as admissible under rules is authorized.
