Consequent upon declaration of Revised result of SAS Part-II Exam, vide HQrs office letter dated 02.07.2024 and for convening of DPC as per AN-XI letter dated 03.07.2024, all the Controller offices are requested to obtain choice stations from candidates who have been declared successful (qualify/pass) as per Revised result in SAS Part-II Exam held between 11th September 2023 to 15th September 2023. The detailed information may be forwarded in the enclosed Annexure "A" through e-mail and as well as through speed post by name to the undersigned, so as to reach this office on or before 11.07.2024 along with Annexure "B" and "C" as enclosed herewith.

- In the above context it may also be brought out to the notice of all these successful candidates to (2).fill their three choice stations out of the deficient stations as mentioned in Annexure "B" of HQrs office Circular No. 25012 (22)/AN-X/Misc. Dated 24/03/2023 (copy attacahed).
- Further, it may also be clarified to the successful candidates that opting for three choice stations as (3). per Para (2) above may not be construed as right for posting to one of these stations and they may be considered for posting at any station on administrative requirement/grounds. However, efforts would be made to accommodate them to the extent administratively feasible. The individuals seeking retention at the same station or seeking transfer to their choice stations other than above on medical grounds may be advised to submit proper medical certificate (alongwith copies of prescriptions and test reports) from the attending specialist, clearly bringing out the disease, since when suffering from and present status etc.duly recommended by GO (AN) as per this office Circular No. AN/X/10050/AVL-10/2023 Dated 14.07.2023 and Transfer Policy dated 28/03/2014.

In continuation of this office letter no. even dated 14/11/2022 as amended

On analysis of various factors affecting the manning of the Department, it has been decided to carve out another category of stations and include additional provisions in the existing transfer policy for transfer/posting at these stations. Henceforth, stations as per Annexure 'A' to this letter will be referred to as "Special Stations" and stations at Annexure 'B' will be referred to as "Deficient Stations". The list will be reviewed after five years by the HQrs office taking into the account data of AVL. The transfer/posting at these stations will be carried out as per provisions given below:

- (1) These laid down provisions are applicable to AAOs. Sr. Auditors and Auditors only.
- (2) Transfers for the Special Stations and Deficient Stations will be carried out by the IQrs office as well as by PCsDA/CsDA
 - (3) Officials posted at "Special Stations" will now be treated as on transfer alert after completion of three years at the stations with cut-off date as 1st April. No further circular or letter will be issued for the same every year.
 - (4) For Prayagraj and Delhi Station, the transfer alert will be treated on completion of five years at the station. However, tenure of AAOs, SAs and Adrs serving in HQrs office and deputation will be excluded from their overall tenure
 - (5) A Circular will be issued by HQrs office seeking 3 choice stations from amongst the Deficient Stations from the officials who are serving in Special Stations and come under alert criteria. This exercise will be done after exhausting AVL. Those who do not give choice stations will be posted out to Deficient Stations as per administrative requirement.
 - (6) The tenure at Deficient stations will be for three years.
 - (7) After completion of tenure at Deficient Stations, the officials will be considered for posting at one of their three choice stations as per AVL. Three valid choice

stations are required to be submitted for consideration otherwise posting may be done as per administrative feasibility.

(8) The officials reverted from Deficient Stations on completion of their minimum prescribed tenure will be given station alert at their new station of posting if they are posted to Special Station only after five years for subsequent cycle.

Those who have earlier served at "Hard stations" and wish to be posted back to one of hard station again; they shall be required to serve one of the Deficient stations before such posting. This provision will be applicable to all stations.

(10) The officials currently posted to Deficient stations will be reverted gradually in a time bound manner as per their turn to one of their choice stations through AVL.

(11) HQ office reserves the right to post any official on administrative ground.

(12) The above provisions will also cover individuals affected by the order issued by HQrs for transfer vide letter no. AN/IX/9010/1/Orgn-Stn.Sr./2023/TR-255to387 & AN/10/10050/AV1./10/2022/Org. Sen./TR-378-470 dated 09.03.2023.
