Subject: Transfer Establishment: DAD.

Election Commission of India has announced holding of General Election to the Legislative Assemblies of Assam, Kerala, Tamil Nadu, West Bengal and Puducherry during the months of March to May. Government of India employees often get deployed on various kinds of election duties by the Election Commission of India.


2. Officers and staff of this department may also be deployed for above mentioned elections on different kinds of duties by the Election Commission of India. This may include officers/staff who are either under order of transfer at this moment or who are likely to be transferred in the ensuing transfer orders issued by this HQrs office or by concerned Controllers' office. Transfer of officers/staff having election duties may interfere with the guidelines issued by the Election Commission of India.

3. In view of the above, the undersigned has been directed to intimate all concerned that following measures may kindly be taken while ordering/implementing transfer orders:

- a) A note may be inserted in all the transfer orders issued henceforth that officers/staff members who are assigned with election duty may be relieved only after the completion of his/her election duty.
- b) Officers/Staff who are already under the orders of transfer issued either by this HQrs or by the Controller' office and who have been assigned with the election duty, may be relieved of their duties only after the completion of their respective election duty.
- c) Representations received from officers/staff members who have been assigned with election duty, requesting for his/her early relieving from his/her present office/place of posting may not be entertained. All such representations made in response to orders issued by the HQrs office need not to be sent to this office and may be disposed off by the concerned PCsDA/CsDA at their end itself.

- d) As regards provisioning of SAS Part -II examination (held in November 2020) passed candidates to the regular vacancies of AAOs; the officers who are deployed on election duty may be allowed to take promotion at their present place of duty. However, the transfer order issued by HQrs office stands and after completion of election duty the officer stands relieved to join new place of posting.
