Subject: Transfer Establishment: DAD- Hard/Tenure station.

Certain stations have been categorized as 'Hard' and 'Tenure' stations for the purpose of transfer/posting and a fixed tenure is prescribed for each station vide HQrs office letter no. 25012/AN-X/2014 dated 15/7/2014. Accordingly, officers and staff are rotated from these stations after completion of prescribed tenure. Keeping in view the prevailing scenario and lack of volunteers for hard stations and number of hard stations needed to be retained, a review has been carried out for hard and tenure stations as enumerated vide HQrs letter dated 15/7/2014.

2; It has been decided with the approval of Competent Authority that henceforth, there would be three types of stations in Defence Accounts Department and categorized as (1) Hard Station (2) North East Region including Sikkim and (3) Other stations. The procedure for posting and transfer in these stations is given below:

- 1) **Hard Stations** – List is enclosed as Annexure Á'. Transfer/Posting (IN/OUT) shall be done by HQrs office only. Tenure in Hard Stations shall be of two years except for Car Nicobar for which it is retained to one year. They shall invariably be repatriated to their first choice station. The order will be issued three months before completion of prescribed tenure. Three choice stations shall be called for and in event it is not administratively feasible to post in first choice station volunteers will be posted to second or third choice station. The minimum physical stay will be 20 months for 2 year tenure and 10 months for 01 year.

- 2) **North East Region including Sikkim** – Governed by guidelines issued by Govt. of India from time to time. Transfer/posting from outside NER shall be done by HQrs office. However, for stations contained in Annexure A; IN/OUT transfer shall be controlled by HQrs office.
- 3) **Other stations** – PCDA/CDA may carry out transfer/posting within their jurisdiction except Delhi, inter-command transfer based on AVL/station seniority and administrative exigencies.

3. Relevant paragraphs of HQrs letter no. 0600/AN-X/Vol. XXI dated 28/3/2014, may therefore please be treated as modified to the above extent.
