Sir.

I am directed to refer to your letter no. AN-I/1466/Estt., dated 31<sup>st</sup> August, 2016 and to state that in exercise of the power conferred on it by Article 324 of Constitution and Section 20B of the Representation of the People Act, 1951, the Election Commission hereby appoints 10 IDAS Officers (as per list enclosed) as Expenditure Observer for the General Elections to the Legislative Assemblies of Uttar Pradesh, Uttarakhand, Punjab, Manipur and Goa, 2017. The Commission has organized briefing meeting to all appointed Expenditure Observers at the Ashok Hotel (Convention Hall), Chanakyapuri, New Delhi on 08.01.2017 as per schedule enclosed herewith.

- 2. Under Section 13CC of the Representation of the People Act, 1950 and Section 28A of the Representation of the People Act, 1951, they will be deemed to be on deputation to the Election Commission from now till the completion of election. Working as Observer of the Election Commission they will be under subject to the control, superintendence and discipline of the Election Commission for their duties performed as Observer.
- 3. As Observer of the Commission, they are entitled for TA/DA as admissible on tour. They will draw TA/DA from their Ministry/Department/Office. The expenditure will be debitable to the Budget grant of their Ministry or Department/Office. They are also entitled to travel by air by any scheduled commercial flight of any Airlines. However, whenever they travel by train, it shall be as per their entitled class.
- 4. The Officer(s) is/are also required to go through "Compendium of Instructions on Election Expenditure Monitoring (September, 2016)" available on official ECI website

- 5. The Officer(s) may be informed that-
- (i) The Officer(s) is/are required to upload their/his/her photograph in the Personal Information Sheet on Observer portal. This is required for printing of Identity Card.
- (ii) User id and password for accessing the Observer portal is 'Observer Code' mentioned against his/her name. The Officer(s) should change password on first login, if they/he/she wish(es).
- (iii) The Officer(s) is/are requested to remain in contact with their Nodal Officer.
- (iv) The deployment order indicating the State, District and Constituency shall be given during the briefing.
- (v) Failure to attend briefing session may result in disciplinary action.
- 6. In this connection, I am directed to forward herewith a list of Expenditure Observers (10 IDAS Officers) with the request to intimate them immediately with direction to ensure their presence in Briefing Meeting at the Ashok Hotel, (Convention Hall), Chanakyapuri, New Delhi on 08.01.2017.
