- 2. Cabinet Secretary has requested this Department to draw up an Action Plan to involve officers and staffs of all Departments/Attached offices and PSUs for promotion of Digital Payments. Initiatives to be covered under the above action Plan are as follows:

 - Training and awareness camps may be organized for the general public involving Banks, Corporates, Self Help Groups, NGOs etc. to train the targeted population in using digital options.
- 3. In view of above, all Divisions of this Department are requested to take the matter with their respective Services/ subordinate Organizations under their control for strict compliance. They may also be directed to furnish an Action taken report in the matter for onward transmission to Cabinet Secretary.
