- 2. The said Reports & Returns being received in the HQrs office have been examined/reviewed and it has been decided by the competent authority to <u>dispense with rendition of Reports & Returns by various PCsDA/CsDA</u> (Monthly/Quarterly reports are not to be furnished to HQrs office).
- 3. However, the Quarterly Report on <u>"Reduction in pendency of court cases"</u> as introduced vide HQrs circular No.AN/LC/Court Cases/Reports dated 09.05.2017 <u>shall continue</u> to be submitted by Nodal Offices till further instructions. The said report may continue to be submitted through e-mail/fax.

- 4. With regard to Court Case Monitoring System (CCMS), it is stated that the years 2016 & 2017 have been added to the drop down list to enable updation of CCMS with the details of CAT/Court cases filed during 2016 & 2017. As such, it is requested that the CCMS may henceforth be updated on regular basis. The data may be updated after each hearing without fail, so as to enable the HQrs Office to generate requisite reports as & when required. Similarly, the CAT/Court cases, which have been finalised/closed, may be deleted from the system.
- 5. It is further requested that the name of the CAT/Court Bench (with Station) may be mentioned under "Remarks" column as the name of CAT/Court Bench is not being reflected in the Reports being generated through CCMS. Further, while entering the details of Contempt Cases, the gist of the order to be implemented & date of order may also be mentioned under "Remarks" column.
- 6. Nodal Officers may ensure that reports are uploaded in CCMS.
