Sub: Implementation of Government's decision on the recommendations of the Seventh CPC - Revision of pension/ family pension for pre-2016 & post-2016 retirees pensioners.

In order to implement the Government decision on the recommendations of Seventh CPC, Ministry of Defence, DESW vide their letter No 17(01)/2016-D(Pen/Policy) dated  $29^{th}$  Oct, 2016 have issued order for revision of pension of pre-2016 retirees which have been circulated to all pension disbursing agencies for implementation vide PCDA(P) Allahabad circular No 570 dated 31.10.2016.

- 2. Ministry of Defence, DESW have now issued following three Government letters on the subject mentioned against each order-
- i) Two letters bearing No 17(01)/2017/(01)/D(Pension/Policy) dated 4<sup>th</sup> Sept, 2017 and No 17(01)/2017/(02)ID(Pension/Policy) dated 5<sup>th</sup> Sept, 2017 for revision of pension of pre-1.1.2016 Defence Forces pensioners/ family pensioners.
- ii) Letter No 17(02)/2016-D(Pen/Policy) dated  $4^{th}$  Sept, 2017 for revision of provisions regulating pension/ gratuity/ commutation of pension/ family pension including casualty pensionary awards in respect of Commissioned

Officers, Junior Commissioned Officers & Other Ranks, retiring or dying in harness on or after 1.1.2016.
