

**Subject:-** Calling for Volunteers among Retired SAOs/AAOs for posting in various PCsDA/CsDA offices as consultant for liaison with courts

## 2. Scope of Work:

The primary responsibilities of the consultant will include:

- Coordinating and holding discussions with Central Government Standing Counsels (CGSCs) prior to important hearings.
- Updating the status of court cases post-hearing.
- Liaising with courts and legal representatives.
- Ensuring timely collection of court orders and related documentation.

## 3. Eligibility:

Retired SAOs/AAOs who:

- · Have experience in pension-related matters, and
- Have not attained the age of 64 years as on 30.09.2025, are eligible for engagement as consultants.

### 4. Period of Engagement:

The initial engagement will be for a period of six months to one year, which may be extended based on performance and administrative requirements.

#### 5. Remuneration:

A fixed remuneration will be paid in accordance with the guidelines laid down in Ministry of Finance, Department of Expenditure OM No. F. No. 3-25/2020-E.IIIA dated 09.12.2020.
