**Subject: Deputation to Posts other than Central Staffing Scheme : IDAS officers**

Circulars inviting applications from eligible and willing IDAS officers for deputation to posts other than those under the Central Staffing Scheme (CSS) are issued from time to time by this office.

2. In order to bring clarity and uniformity to the application process, HQrs Office Circular No. AN-I/1320/1/XLII/Vol dated 21.04.2023 stipulates that such applications for Non-CSS posts shall be permitted only after completion of nine (09) years of service in the Department. Further, only those applications submitted against Deputation circulars issued by this office which fulfill the prescribed eligibility criteria therein shall be considered.

3. The above guidelines were reiterated vide HQrs Circular No. AN-I/1320/1/XLII dated 18.10.2023. Of late, it has been observed that applications for deputation to Non-CSS posts which do not fulfill the prescribed criteria are still being received at HQrs Office.


4. It is, therefore, once again reiterated that applications which do not conform to the criteria laid down in HQrs Circulars dated 21.04.2023 and 18.10.2023 shall not be entertained. A copy of the circulars are enclosed herewith.

**Subject: - Deputation to the posts other than Central Staffing Scheme:- IDAS Officers.**

Circulars inviting applications among the eligible and willing IDAS officers for considering their deputation to the posts other than Central Staffing Scheme are being issued from time to time.

2. In order to bring clarity while sponsoring the names of the willing officers and to enable uniform implementation, the undersigned has been directed to request that the following points may be noted for strict compliance in future:-

- a) Since deputation under CSS is permitted after completion of 9 years of service in the department, the same principle will be followed to allow deputation other than CSS meaning thereby no deputation either CSS or Non CSS will be permitted before completion of 9 years of service in the department.
- b) In case of Non CSS deputation, only those applications will be considered who will apply against the circular issued by the O/o the CGDA and will fulfill criteria laid down therein.

3. This may be brought to the notice of all concerned for strict compliance please.

**Subject: Deputation to the Post other than Central Staffing Scheme: IDAS officers**


