Subject: Selection of one (01) SAO to serve as Faculty in RTC, Lucknow

It has been decided with the approval of the Competent Authority to call for names of volunteers among eligible SAOs for selection of one (01) Senior Accounts Officer to serve as Faculty at RTC Lucknow. The SAO selected as Faculty will be governed by the provisions contained in the DAD Training & Development Policy, 2024, as amended from time to time.

2. The following eligibility conditions shall apply:

- (i) A cooling off period of 3 years would be required to be completed for considering the candidature of officers for serving as faculty, who have earlier served/serving as faculty.
- (ii) A minimum stay of 2 years at present station on the date of submitting his/her application or prescribed length of tenure for hard and tenure station would be required to be completed by the volunteer officers before being eligible for the post of Faculty in training centres.
- (iii) The officer applying for the post of Faculty should not have applied for other panel for transfer to Bhutan/Tajikistan, J&K Region, North East region, Andaman & Nicobar Islands etc.
- (iv) The Officers applying for the post of Faculty in Departmental Training Centres should have minimum residual service of 2 years.
- (v) Officers who are under orders of transfer issued by HQrs Office at the time of applying for the Faculty post shall not be eligible for consideration.

3. Willing and eligible officers may forward their applications as per the enclosed Annexure 'A', duly recommended by the concerned Head of Department, to CGDA HQrs (Training Division) through e-mail at trgdiv-brar.cgda@nic.in latest by **30.03.2026**.
