Subject: - Revision of Seniority in HAG: - IDAS Officers

In compliance to the order of the Hon'ble Tribunal dated 18/08/2017 in OA No. 3345/2015 filed by Smt. Rasika Chaube which was upheld by the Hon'ble High Court of Delhi vide its order dated 05/11/2019 in WP (C) No. 9694/2017 filed by UoI, seniority in JAG & SAG were revised vide this office letters of even no. dated 28.07.2020, 01.04.2021 and 16.06.2021. Consequently, a Review DPC for the vacancy year 2013-14 for promotion to HAG of the IDAS was convened on 05/07/2021.

2. The said Review DPC after examining all the relevant facts, recommended the name of Smt. Rasika Chaube for promotion to the Higher Administrative Grade of the IDAS against the vacancy year 2013-14 at S No. 3-A above Sh. Sanjeev Kumar, (S No. 4) and below Sh. D.C.S. Negi (S No. 3). Accordingly, her name stands recommended at S No. 3A in the consolidated panel in place of S. No. 4 in the extended panel for the vacancy year 2013-14 as had been recommended by the original DPC held on 16.08.2013.

3. Accordingly, the Appointments Committee of the Cabinet has approved the empanelment of Smt. Rasika Chaube for promotion to the Higher Administrative Grade (HAG) of the IDAS on notional basis w.e.f. the date of promotion of her immediate junior, Shri Sanjeev Kumar, IDAS on 06.11.2013 and on actual basis w.e.f. the date of her assumption of charge of the post on 23.01.2014 i.e. at Sl. No. 3-A above Shri Sanjeev Kumar at Sl. No.4 and below Shri D.C.S. Negi at Sl. No. 3, in the panel for the vacancy year 2013-14. This would not have any monetary implications and would only result in the revision of inter se seniority of Smt. Rasika Chaube as her junior has been promoted to HAG of the IDAS.

4. Accordingly, the seniority list (panel position) of all the officers assessed in the original DPC dated 16.08.2013 as well as after review DPC for promotion in HAG is as under:-
