**Sub:-** Selection of one AAO to serve as faculty in RTC Lucknow.

It has been decided by the competent authority that names of volunteer AAOs may be called for selection of one AAO as faculty for RTC Lucknow for imparting training to the officers and staff. AAOs, who are selected as training faculty, would be eligible for training allowance in accordance with the extant rules. The volunteers must have good skills and proven aptitude for training. Before appointment to the post of training faculty in RTC Lucknow, the volunteer AAOs would have to undergo a screening test which would be conducted by a Screening Committee, constituted by HQrs. office.

2. It is, accordingly, requested that the names of volunteers amongst AAOs may be provided as per the enclosed format (Annexure-A) latest by 18.10.2024. Names of volunteers who would be retiring on or before 31<sup>st</sup> October 2026 may not be forwarded.
3. While forwarding the name of volunteers, the Head of Offices concerned (PCsDA/CsDA/PIFAs/PIFAs/IFAs) are requested to **furnish their specific recommendations** along with the APAR gradings for the last 03 years for consideration by the Screening Committee.
4. The under mentioned conditions for applying for the post of faculty in training institutes, as stipulated in DAD Training & Development Policy 2024 (uploaded on CGDA WAN), may also be kept in view while forwarding the names of volunteers for the post of faculty:-
  - i. A 'cooling off period' of 3 years is required to be completed by the AAOs who have earlier served as faculty, for considering their candidature for serving as faculty.
  - ii. A minimum stay of 2 years at present station or prescribed length of tenure for hard and tenure station would require to be completed by the volunteer officers before being eligible for the post of faculty in training centre.

- ii. A minimum stay of 2 years at present station or prescribed length of tenure for hard and tenure station would require to be completed by the volunteer officers before being eligible for the post of faculty in training centre.




- iii. The officer applying for the post of faculty should not have applied for other panel for transfer to Bhutan/Tajikistan, J&K Region, North East Region, Andaman & Nicobar Islands etc.
  - iv. The officer applying for the post of faculty in Departmental Training Centre should have minimum residual service of 2 years as on **31.10.2024**.
