Sub: Selection of AAOs to serve as faculty in RTC Lucknow

It has been decided by the competent authority that names of volunteer AAOs may be called for selection of training faculty for RTC Lucknow for imparting training to the officers and staff. AAOs who are selected as training faculty would be eligible for training allowance in accordance with the extant rules. The volunteers must have good skills and proven aptitude for training. Before appointment to the post of training faculty in RTC Lucknow, the volunteer officers would have to undergo a screening test which would be conducted by a Screening Committee, constituted by HQrs. office.

- 2. It is, accordingly, requested that the names of volunteers amongst AAOs in your offices may be provided as per the enclosed format (Annexure-A) latest by **25.09.2021**.
- 3. NIL report is also required.
- 4. While forwarding the names of volunteers, the Head of offices concerned (PCsDA/ CsDA/PIFAs/IFAs/PCA(Fys)/CsDA (RTC) are requested to **furnish their specific recommendations** along with the APAR gradings for the last 03 years for consideration by the Screening Committee.
- 5. The under mentioned conditions for applying for the post of Faculty in training institutes, issued vide this office letter no. TD/3279/Policy/2017/part-file dated 09.04.2021 as Amendment no. 11 to the Training & Development Policy 2019 (uploaded on CGDA website), may also be kept in view while forwarding the names of volunteers for the post of faculty:
 - A 'cooling off period' of 3 years would require to be completed for considering the candidature of officers for serving as faculty, who earlier served/serving as faculty.

A minimum stay of 2 years at present station or prescribed length of tenure for hard and tenure station would require to be completed by the volunteer officers ii. before being eligible for the post of faculty in training centre.

The officer applying for the post of faculty should not have applied for other panel for transfer to Bhutan/Tajikistan, J&K Region, North East Region,

Andaman & Nicobar Islands etc.

The officer applying for the post of faculty in Departmental Training Centre iv. should have minimum residual service of 2 years as on 25.09.2021.
