Subject: Nomination of Vigilance Officers in Defence Accounts Department (DAD)-reg.


In pursuance of the approval accorded by the Competent Authority and in accordance with the provisions contained in the Vigilance Manual, 2021 of the Central Vigilance Commission (CVC), the Vigilance Officers nominated for various offices of Pr.CsDA/CsDA are detailed in Annexure 'A' appended to this communication. Pr.CsDA/CsDA are requested to prominently display their names, designation, phone numbers/email and official address to the stake holders concerned as per existing CVC instructions.

2. The Vigilance Officers shall assist the Chief Vigilance Officer (CVO), Defence Accounts department (DAD) in the implementation of preventive and punitive vigilance measures, with due focus on strengthening internal controls, identifying systemic deficiencies, and ensuring compliance with laid-down procedures. They shall also conduct inquiries/investigations strictly in accordance with the directions issued by the CVO and the procedures prescribed in the Vigilance Manual, 2021.
3. The Vigilance Officers shall be responsible and accountable, inter alia, for the effective discharge of vigilance functions in their respective offices, including the timely submission of prescribed vigilance reports/returns, and relevant information to HQrs Office. Their performance in this regard shall also be reflected in their Self assessment in their APARs and come in for suitable appraisal at higher levels of Reporting/Reviewing/Acceptance.

4. To ensure effective oversight and uniformity in vigilance administration, the CVO may conduct periodic reviews of their functioning, and apprise the CGDA.
5. The tenure of the nominated Vigilance Officers shall normally be for 3 (three) years. However, in cases where a vacancy arises on account of transfer/posting/deputation/retirement, or any other contingency, the concerned Pr.CsDA/CsDA shall immediately forward a fresh panel of eligible officers to the HQrs Office for consideration. Simultaneously, in order to ensure continuity and uninterrupted discharge of vigilance functions in their respective offices, Pr.CsDA/ CsDA may appoint an interim Vigilance Officer and move a proposal seeking ratification of the same from the HQrs office.

This issues with the approval of CGDA.
