- 2. The Competent Authority has also decided to retain the officers in their present offices on promotion. No. 30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors.) arising out of final judgement and order dated 15/07/2011 in CWP No. 13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and Special Leave to Appeal (c) No. 31288/2017 arising out of Hon'ble Delhi High Court judgement dated 23/08/2017 and Hon'ble Supreme Court order dated 27/11/2017 in SLP (C) No. 17491/2017 (UOI & Ors v/s Sanjeev Malhotra & Ors) and Hon'ble High Court of Punjab & Haryana at Chandigarh order dated 06/02/2017 in CWP No. 24671 of 2016 (Union of India & Ors v/s Shaneel Rana & Others) and other related court cases.
