Subject - 66th NDC Course at National Defence College scheduled from 05th January 2026 to 27th November 2026.

The 66th NDC Course at National Defence College, New Delhi is scheduled to commence from 05th January 2026. The duration of the course is 47 weeks. A few seats at the NDC Course are earmarked for the Civilian Officers belonging to various

- The broad objective of the NDC Course is to provide a holistic view of 2. contemporary economic and political scenarios and related aspects with particular emphasis on security issues. A better understanding among professionals drawn from different disciplines in the country having divergent backgrounds and value is yet another objective of the course. Visits to important military stations and frontier posts and some foreign countries form integral part of the course curriculum.
- Qualification Requirements for the selection of officers to be nominated for the course are as under:-
 - IAS/IPS/IFS officers having not less than 14 years of completed service. a) b)
 - Officers of other Central Civil Services of the rank of Director/Senior Deputy Secretary of a Central Ministry or equivalent who are likely to reach policy making level of Joint Secretary or equivalent having not less than 16 years of completed services. c)
 - Below 54 years of age as on 01.01.2026, with sound physical and mental health.
 - Excellent record of past performance. d)
 - Clearance from Vigilance and disciplinary angle. e)
- The officers should not have undergone a training programme of 12 weeks or 4. more duration in India during a period of 5 years preceding the date of commencement of this course. Further, the officer should not have undergone a programme of training abroad of more than 2 weeks in preceding 2 years, more than 1 month in the preceding 3 years or more than 6 months in preceding 5 years.

- 6. Cadre clearance, Vigilance Clearance and photocopies of last 5 years Annual Performance Appraisal Reports (APARs) of the nominated officers, duly attested by an officer not below the level of Under Secretary may be sent along with the nominations. Original APARs should not be sent.
- 7. The officer selected for the NDC Course will be required to execute a 'Bond' prior to his/her joining the NDC Course and submit the same to his/her Cadre Controlling Authority stating that he/she would serve the Government for a period of five years and he/she would be willing to work in Ministry of Home Affairs, Ministry of Defence, Ministry of External Affairs, NSCS and other security-related organizations on completion of the Course, or to repay the total expenses incurred on the NDC Course in the event of his/her resignation, voluntary retirement or quitting the NDC Course without completing it.
- 8. The Officers applying for nomination to this course should not be allowed to apply for deputation to other Ministries/Departments/Organizations.
- 9. In case an officer is selected, it will be mandatory to join the course.
- 10.
