



I am directed to refer to your letters no. AN-I/1341/3/Election-VI, dated 01.02.2016 and 13.04.2016 and to state that the Expenditure Observers (as per list) deployed in the General Elections to the Legislative Assemblies of Assam, Kerala, Tamil Nadu and West Bengal, 2016 by the Commission from among the IDAS Officers, sponsored by CGDA are required to make their last visit on **25<sup>th</sup> day after declaration of results of elections** i.e. on **13<sup>th</sup> June, 2016** and shall be present in the "Account Reconciliation Meeting" to be convened by the DEOs on the **26<sup>th</sup> day** after the declaration of results in pursuance of the Commission's letter no. 76/Instructions/EEPS/2015/Vol. II, dated 29<sup>th</sup> May, 2015 (copy enclosed).
