The case has been considered by the DAPB. The following facts have been brought to the notice of the DAPB:

- (I) Shri Mohd. Qadar Uddin, SAO PERSONAL INFORMATIONS and is under treatment at AIIMS, New Delhi since 09.05.20111. He requires regular check up and frequent consultancy with doctors at AIIMS.
- (II) PERSONAL INFORMATION Surpose of August and the wine
- (III) Shri Mohd. Qadar Uddin, SAO was initially transferred to AAO (Army) Agra on his promotion to the grade of AO in September, 2012. However subsequently his place of posting was changed from AAO (Army) Agra to Main Office, PCDA (BR) Delhi Cantt on self medical grounds i.e. IPERSON ALLIENTED MATION and taking treatment from AIIMS, New Delhi.
- (IV) Shri Mohd. Qadar Uddin, SAO subsequently applied for temporary deputation as Assistant Haj Officer for Haj duty in Saudi Arabia for the year 2013 and 2014 and had produced "Certificate of Fitness" issued by CMO Aligarh on 02.02.2013 and 25.01.2014 respectively.

The DAPB after considering the above facts is of the opinion that Shri Mohd. Qadar Uddin, SAO applies for retention in Delhi on self medical grounds whenever he is transferred out from Delhi. However, he had submitted Certificate of Fitness for his deputation to Haj duty in Saudi Arabia on two occasions in the past. This raises reasonable doubts about his actual medical condition. In view of the above, DAPB recommends that he may be posted to LAO (AF) Gorakhpur so as to enable him to continue his medical treatment as Gorakhpur has got reasonable medical facilities. Further DAPB recommends that Shri Krishan Kumar, AAO (Roster No. 132) (whose representation regarding change of his place of posting from LAO (AF) Gorakhpur to hard station so as to retain his government accommodation at Delhi is also under consideration of the DAPB) be posted to AO GE Dinjan on his promotion to the grade of AO in place of Shri Mohd. Qadar Uddin, SAO.

The case has been considered by the DAPB. The following facts have been brought to the notice of the DAPB:

- (I) Shri Kailsah Chander was posted to AO GE 881 EWS Poonch on his promotion to the grade of AO on December, 2012.
- (II) Shri Kailash Chander, SAO on his reversion from AO GE 881 EWS, Poonch (Hard Station) had given choice station as Pathankot, Gurdaspur and Dalhousie. However, he was transferred to DPDO Mandi.
- (III) Shri Kailash Chander, SAO has stated that Mandi is also equal to hard station for him as neither facility like Govt accommodation available in the station nor well connected with Train/Air. He cannot visit Pathankot to meet his family more than once in month/two months as he did during his posting at Poonch.
- admission/tuition fee for three months. Therefore at this stage he is not in a position to change the station/school.

The DAPB has gone through the case and felt that Shri Kailash Chander, SAO should have been accommodated in Pathankot against the existing vacancy available at that time in the station keeping in view of his repatriation from hard station instead of posting of other officer who was reverted from peace station. In view of the above, DAPB recommends that Shri Kailash Chander, SAO may be posted to AAO (Pay) Pathankot in excess and simultaneously an alert notice may be served to station seniors of Pathankot. This excess may be liquated by posting of station senior from Pathankot.
