Officers may be informed that their promotion to Senior Time Scale of IDAS is subject to outcome of CWP No. 17376/2018, challenging the order of Hon'ble CAT Chandigarh bench dated 28.02.2018 in OA No. 060/00666/2017 filed by Shri Inder Kumar in the Hon'ble High Court of Punjab & Haryana at Chandigarh and SLP No. 30621 of 2011 in the matter of Jarnail Singh & others which is under consideration in Hon'ble Supreme Court. This fact may also be indicated in the Pt. II O.O. notifying their promotions.
