Subject: Promotions from the grade of Senior Accounts Officers (Group 'B') to the Junior Time Scale (Group 'A') of the Indian Defence Accounts Service on regular basis.

The Government of India, Ministry of Defence (Finance) have approved promotion of Senior Accounts Officers serving in the offices/organizations indicated against each in **Annexure 'A'** to this letter to the Junior Time Scale in pre-revised scale of PB-3 (Rs. 15600-39100 plus Grade Pay 5400/-) (6th CPC)/ pay level-10 of 7th CPC of the service on regular basis. The Competent Authority has decided the postings on promotion in the offices/organizations as indicated against their names. Accordingly, the officers may, therefore, be relieved of their present duties. On reporting, the officer(s) may be promoted to the Junior Time Scale of IDAS on regular basis and designated as ACDA/Dy. IFA etc. whichever is applicable. **The promotion of officers shown in Annexure 'A' shall be with immediate effect or from the assumption of charge of the new post whichever is later, provided no disciplinary/criminal case is pending against the officers and they are not under suspension.**

2. Further, it is also stipulated that in pursuance of DOP&T OM No. 36012/11/2016-Estt. (Res-I) (Pt. II) dated 15.06.2018, promotions shall be subject to further orders which may be passed by the Hon'ble Supreme Court on account of interim orders/directions in Special Leave to Appeal (C.) No. 30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors.) arising out of final judgement and order dated 15/07/2011 in CWP No. 13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and Special Leave to Appeal (c) No. 31288/2017 arising out of Hon'ble Delhi High Court judgement dated 23/08/2017 and Hon'ble Supreme Court order dated 27/11/2017 in SLP (C.) No. 17491/2017 (UOI & Ors v/s Sanjeev Malhotra & Ors) and Hon'ble High Court of Punjab & Haryana at Chandigarh order dated 06/02/2017 in CWP No. 24671 of 2016 (Union of India & Ors v/s Shaneel Rana & Others) and other related court cases.

3. The officers may also be requested that on reporting in the new office of posting, they may inform their date of joining, correspondence address, telephone Nos. (Official, Residential & Mobile and email id on an1-pinklist.cgda@nic.in for updation of the Civil List.

4. The officers approved for regular promotion to the Junior Time Scale of the IDAS will be on probation for a period of two years or up to the date of superannuation whichever is earlier from the date of promotion in the first instance. Necessary assessment reports may be forwarded to this office on completion of each year of probation.
5. The relief of the officer shall not be deferred on the ground that a representation has been submitted for change of place of posting or on the ground that reliever has not reported/been posted. It may be brought to the notice of the officer that no representation for change of posting etc. will be entertained in any case, as the IDAS carries a definite liability to serve any where in India including field service in or out of India. The Pr. Controllers/Controllers may also ensure that representations are not unduly forwarded.
6. TA and joining time as admissible under rules may be authorized to the officers.
7. The date of officers' assumption of charge may please be intimated to the HQrs office by fax/ email. The copies of Part II Office Orders notifying the assumption of charge and fixation of pay in the new grade may be endorsed to the HQrs Office.
