Subject: Promotion of Steno-II to the grade of Steno-I for the vacancy year 2023.

The promotion of **05 (five only)** individuals (Steno-II) as per **Annexure 'A'** to this letter, who have been recommended "FIT" by the DPC held in respective offices, have been approved for promotion in the grade of Steno-I in pay matrix Level-6, (as per 7th CPC) w.e.f **01.01.2023** or from the date of assumption of charge of the higher post, whichever is later in the same organization where they are serving at present.

2. The promotion may please be notified in the name of PCsDA/CsDA as Appointing Authority, in the Office order. Before promotion of the individuals, it may be ensured that none of the circumstances enumerated in Para 2 of DOP&T OM No.22011/4/91-Estt (A) dated 14.09.1992 have arisen before promotion. If such circumstances have arisen, the promotion shall not be released and instead treated as "Deemed Sealed Cover" case in terms of Para 7 of the said OM. It may also please be ensured that individual is not promoted till expiry of penalty period, if he/she is undergoing the period of penalty. The promotion order notified by your office should also indicate that he/she has been selected for the promotion of the grade of Steno-I by PCDA/CDA. The promotion order should also indicate that he/she may exercise an option within a period of one month as DP&AR OM No.1/2/97 Estt (Pay-I) dated 23.04.1999.

3. The case of refusal of promotion may be dealt with by PCDA/CDA office itself, being the appointing authority in light of provisions contained in DOP&T OM No.22034/3/81-Estt(D) dated 01.10.1981. The HQrs. office may please be informed accordingly.

4. It is requested to provide the details of candidates as per HQrs letter dated 10.10.2022 in lieu of promotion alongwith a copy of part II Office Order notifying the promotion from Steno-II to Steno-I.
