Subject: Promotion of MTS to the grade of Clerk on passing of Departmental Examination held on Jan 2016

The Competent Authority has decided to promote MTS to the grade of Clerk, as per **Annexure** 'A' to this letter with effect from 31 /03/2016 and individuals mentioned in **Annexure** 'B' from 01/04/2016, or from the date of assumption of charge of the higher post, whichever is later in the same organization where they are serving at present in the pay scale of Rs 5200-20200/- with a grade pay of Rs 1900/- in the Pay Band- I.

- 2. The individuals, who have not passed the typing test will be eligible for increment only after passing of the typing test and they will further not be considered for promotion to the grade of Auditor before they either pass the typing test or get exemption from the typing test. It is also observed that some of the Controller(s) has adjudicated the individual as 'Unfit' due to the reason that they have not yet passed the typing test, therefore, review DPC may be convened in all such cases in light of DOP&T OMs dated 29/09/1992 & 14/09/1995.
- 3. The promotion may please be notified in the name of PCDA/CDA as Appointing Authority in office order in the manner prescribed in this office confidential letter No. 0636/AN/D dated 18/07/58 and AN/XII/12201/O/3/Vol.III dated 24/09/84. Before promoting the individuals, it may be ensured that none of the circumstances enumerated in Para 2 of the DOP&T OM No. 22011/4/91 Estt. (A) dated 14/09/92 have arisen before promotion. If such circumstances have arisen, the promotion shall not be released and instead treated as "Deemed Sealed Cover" case in terms of Para 7 of the said OM. At the time of notification of their promotion it may also be ensured that they are not undergoing penalty i.e. Reduction to the lower stage of scale of pay or stoppage of increment etc.
- 4. If the promotion is not notified for any reason, this fact may be brought to the notice of HQ office immediately.

- 5. Cases of refusal of promotion, if any, may be dealt with by the Controllers themselves in their capacity as an Appointing Authority in the light of provision contained in DOP&T OM No. 22074/3/81- Estt (D) dated 01/10/81 and our circular No. AN/XII/12201/O/3/87 dated 24/11/87.
- 6. While issuing order of promotion, the attention of the individuals may please be drawn to the provisions of Ministry of Personnel, Public Grievances and Pension (DOP&T) OM No. 1/12/97-Estt. (Pay-I) dated 23/4/99 and clarification No. 2 of Govt. of India, Ministry of Finance F. No. 1/1/2008- IC dated 13.9.2008 regarding exercising of an option by them for fixation of their pay as Clerk.
