  - (d) Rectification of other errors and omissions;
  - (e) Revaluation does not mean remarking of the answers.
- 3. Applications may be preferred as per enclosed proforma within the prescribed time limit after fulfilling the conditions laid down in Rule 19 of the SAS Rules and forwarded to this office by 17.08.2015. A report regarding dispatch of all applications received for revaluation in your office may be sent so as to reach this office by 27.08.2015.
- 4. While forwarding the requests for revaluation, it may be ensured that the candidates concerned have secured 30% of marks in the Paper(s) for which they desire revaluation.
- 5. Applications of candidates which are not preferred within the prescribed period of 45 days and do not fulfill the requisite conditions for revaluation, may not be entertained/forwarded to this office. Instances have come to the notice of this HQrs office that PCsDA/CsDA are forwarding applications for revaluation after due date of submission of such requests is over. This may be avoided.
