

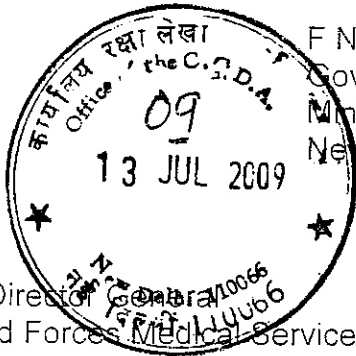

I am directed to refer to the Definition in Para 3 (i) on page XV of RMSAF 1983 is amended to read as: -

'Wholly dependent parents' means parents who normally reside with the officer and whose total monthly income does not exceed Rs. 3500/- plus the amount of dearness relief on basic pension of Rs. 3500/- as on the date of consideration.

2. Para 4 (i) on Page XV of RMSAF 1983 is amended to read as: -

'Wholly dependent parents' means parents who normally reside with the JCOs, etc. and whose total monthly income does not exceed Rs. 3500/- plus the amount of dearness relief on basic pension of Rs. 3500/- as on the date of consideration.
