Amendment No 13
Chapter-3 (Add Para 3.2 under Para 3.1)

For Training on General Topics	The training on general topics to the staff/officers of the offices which are not mentioned in the existing training jurisdiction, shall henceforth be imparted by the nearest Departmental Training Centres.
For Training on Specialized Areas	The training on specialized areas (like Border Roads, R&D, CSD etc.) to the staff/officers shall henceforth be imparted, by the Departmental training centres designated vide Amendment No-5 to Chapter-03 Para 3.1, circulated vide this office letter no.TD/3297/T&D Policy/2019 dated 13 <sup>th</sup> July, 2020.
