
Subject: Training course for IFD officials in Public Procurement Framework of Govt. of India.

It has been intimated that DoE in collaboration with AJNIFM have developed e-Training course on Public Procurement Framework in Gol which is now live on [url: https://igotkarmayogi.gov.in.](https://igotkarmayogi.gov.in)

2. The course has five e-Learning Modules on Integrated Finance Divisions, General Financial Rules, Public Procurement of Services and Government e-Market Portal. These training modules are highly beneficial for officials working in IFD Division. The training course is compulsory for all IFD officials. **Public procurement framework of GoI**

The expenditure on public procurement is a very significant part of Government's overall expenditure. The framework of government's expenditure is based on General financial Rules, last updated in 2017 by including the reforms brought in by the government in budgeting and focusing on outcomes through improved outcome budget document. Following the digitalisation, the focus is now on Public Finance Management System (PFMS), Direct Benefit Transfer (DBT) to ensure efficient delivery, introduction of new e-procurement platforms like Central Public Procurement Portal, and Government e-Market (GeM) Portal.

GFRs lay down the procedure of financial discipline and administrative due diligence. These rules are to be followed by all Government Ministries and Department for making expenditure out of the budget provided to them, apart from following the relevant rules, regulations and guidelines, etc.

The expenditure proposals including public procurement proposals are examined by Integrated Finance Divisions of the Departments with respect to prevalent rules given in the GFRs and other guidelines issued from time to time by the various government authorities. For this purpose, Integrated Financial Advisors are supported by other officers in respective IFDs. In order to make the officers posted in IFDs for the first time and also to enhance the competency of the officers posted in IFDs, Department of Expenditure and Arun Jaitley National Institute of Financial Management (AJNIFM) have come up with e-Learning modules on General Financial Rules.

Five e-Learning Modules have been developed, namely, Integrated Finance Divisions, General Financial Rules, Public Procurement of Goods, Public Procurement of Works, Public Procurement of Services and also on Government e-Market Portal.

These e-learning modules will be quite helpful to the officers posted in Integrated Finance Divisions in acquiring abilities and sharpening their skills and competencies. These e-Learning Modules will be equally useful for all other officers who are working in Administration Division while processing there expenditure proposals.
