**Subject: Emergency Powers (Schedule 23 of ASP in DFPDS-2016) in the wake of COVID-19**

Sir,

I am directed to convey the sanction of the competent authority for according Emergency Powers (Schedule 23 of ASP in DFPDS-2016) to Army Commanders (GOC-in-C), Corps/Area Commanders and Division/Sub-Area Commanders for expediting the procurement/repairs to meet the requirement of establishing and running quarantine facilities/isolation facilities and augmenting these facilities with items, materials, equipment, stores, rations, hygiene chemicals, etc. and provision of other services as part of measures for efficient handling of COVID-19 outbreak out of Defence Budget.

2. Emergency Powers (Schedule 23 of ASP in DFPDS-2016) to expedite the procurement/repairs for establishing and running quarantine and isolation facilities for meeting the requirement of COVID-19 outbreak are accorded to Army Commanders as given below under whose jurisdiction the quarantine/isolation facility is established:

(a)	GOC-in-C	-	Full Powers
(b)	Corps Cdr/Area Cdr	-	Rs. 50 lakhs
(c)	Division Cdr/Sub-Area Cdr	-	Rs. 20 lakhs

3. The above powers are delegated for a period of three months from the date of issue of this letter with a provision for revision/extension, thereafter.

4. This sanction is issued with the concurrence of MoD (Fin/GS-I) vide their Dy No. 23(3)/GS-I/2008 dated 27<sup>th</sup> March, 2020
