Minutes of the 21st Annual Meeting of DASCB

The 21st Annual meeting of Defence Accounts Sports Control Board was held on 25th Feb 2019 at 14.30 hrs in Hqrs. Office and the following were present.

- 2. At the outset, Secretary DASCB welcomed the Chair and all members of the board and opening remarks were delivered. Further Secretary DASCB gave a presentation on DASCB activities for the last financial year.
- 3. Minutes of the 20th Meeting of DASCB held on 23.02.2017 were confirmed.
- 4. As far as the agenda no. 2 is concerned, PCDA (AF) Dehradun regretted and showed his inability to conduct the tournament during this financial year due to paucity of funds and agreed to conduct All India DAD Table Tennis tournament during 2019.
- 5. Following sports calendar was discussed and finalized with the consensus of all board members:
 - (A) All India DAD Volleyball Tournament to be organized at Secunderabad by CDA Secunderabad during April / May 2019.
 - (B) All India DAD Table Tennis Tournament to be organized at Dehradun by PCDA(AF) Dehradun during June / July 2019.
 - (C) All India DAD Cricket Tournament to be organized at Pune by PCDA (SC) Pune in the month of Oct / Nov 2019.

- 6. PCDA (AF) suggested for creating a data base of all players recruited under sports quota for doing an age wise analysis. The same was accepted by the chairperson.
- 7. With reference to recruitment of sportspersons, it was deliberated and decided that recruitment should be done logically in those game which requires national level participation of DASCB teams. Sr.Jt.CGDA(AN) suggested that earlier recruitment was done 6 -7 years back and many players recruited then may not be active presently. CGDA & Chairperson DASCB directed that the recruitment of sports persons should be given top priority.
- 8. The chairman has directed that the recruitment should be done in a transparent manner by adopting DASCB rules/DOPT guidelines by a nominated committee. PCA (Fys) suggested that field trials, which were not part of recruitment during previous drive, should be included in this year process as per the rules. The same was agreed by the chair.
- 9. PCDA Bangalore suggested that there is need to revise the posting policy of the players recruited under sports quota. Players of team sports should be posted together to ensure their regular practice and team building. Sr. Jt.CGDA(AN) stated that affiliation of teams and coaching facilities also needs to be consider while deciding the postings of sportspersons. The CGDA has directed to prepare a posting policy by involving distinguished sports players of the department and admin authorities.
- 10. CGDA directed that there should be an annual selection procedure to identify a DASCB national team for every sports based on the annual field trails. The selected teams / players will take part in various tournaments under the aegis of DASCB in that particular year.
- 11. The Chair suggested to review the performance of the current DASCB Hockey team before processing the case for affiliation of DASCB with Hockey Federation of India.
- 12. Affiliation of DASCB cricket team with Delhi and District Cricket Association (DDCA) is agreed to by the Chairperson. The same will be processed at the earliest.

13. It has been suggested that the participation of various DASCB teams in recognized open

tournaments will be decided on case to case basis. The DASCB will process the request received

from organizers for the approval of Chairperson DASCB. As far as the participation of veterans

players in open tournaments is concerned, the DOPT guidelines will be followed.

14. The Chairperson advised that all field controllers should give immediate attention to all

DASCB circulars and ensure its unquestioned compliance. PCDA (AF) stated that there is a

delay in receipt of circulars or letters due to which willing participants are unable to participate

in events. The Chairperson directed to upload all DASCB circulars on Hqrs website for

immediate circulation to all concerned.

15. PCDA (AF) Dehradun requested the chairperson for construction of Badminton Court in

Dehradun. It was decided that the same will be dealt separately by DAD project section.

16. The recommendation of the committee constituted for resource generation was accepted

by the chairperson, except that the point related to deduction of annual subscription of Rs.60/-

from salaries of officers and staff. It was agreed that DASCB may accept Donations/ CSR/

Sponsorships from public and private individuals, Institutions etc. As per the recommendations

of the committee, the organizing PCsDA/CsDA offices can also raise funds through

advertisements, souvenirs etc.

17. Secretary DASCB intimated that additional grant is required for DASCB to conduct

tournaments this year and arrangements for necessary kits/ training to players. Chairperson

directed to take up the matter with MOD for enhancement of annual grant of DASCB.

18. The meeting ended with vote of thanks from Secretary DASCB.
