The IFAs may open the IFA cells in the respective Ordnance Factories to deal with the Finance functions like participation in the TPCs, PFCs, CNCs, vetting of requirement, Formulation and monitoring of Budget, vetting of Sanction Orders for procurement cases, pricing of products etc. and the manpower for these functions will be drawn from amongst the officers and staff posted in the Branch AOs. The PCA (Fys) Kolkata and IFAs will work out the requirement of manpower for Finance and Accounts functions within the existing manpower, within 15 days.

4. Separate orders will be issued in this regard on finalization of the division of manpower by PCA (Fys) Kolkata and IFAs.
