Subject: Preliminary Examination, July, 2012 for admission to SAS Part-I Examination (Extension of date).

Reference: HQrs. Office circular of even No dated 1st June 2012.

In continuation to HQrs office circular cited under reference regarding holding of preliminary examination on 31st July 2012, it is stated that a proposal for reducing the criteria of qualifying marks from 60% to 50% for the Preliminary Examination(Test) was mooted to MoD(Finance). MoD(Finance) vide their letter No F.26(1)/C/2007 dated 14.6.2012 have accorded approval to amend the relevant part of Rule 16 of SAS Rule, 2007 as under:

"A candidate will be declared to have passed the Preliminary Test if he secures not less than 50% marks in each paper."

2. In view of the modification of SAS Rule 16, the minimum qualifying pass marks for forthcoming Preliminary Examination (Test) for General category candidates and SC/ST candidates fixed by Competent authority is as under :-

Category of candidates	Pass Marks in Paper-I (out of 100)	Pass Marks in Paper-II (Out of 100)	Remarks
General category	50	50	-
SC/ST category	45	45	Under relaxed standard in terms of Rule 23 of SAS Rule

3. Consequent upon reduction in qualifying criteria for Preliminary Examination (Test), more number of candidates are expected to appear. Accordingly, it has further been decided by the Competent Authority to reschedule the Preliminary Examination (Test) on **21st August 2012**. The Preliminary Examination shall now be conducted as per following schedule/programme:-



		PART-'A' Section-I (Common to all)	Candidates are to answer 50 questions each carrying 1 (one) mark.
		PART-'B' (Optional) Section-II – Army Section-III – Air Force Section-IV – Navy Section-V - Factory	Candidates may choose any one from Section-II to V irrespective of the organization in which they are serving. Candidates are to answer 50 questions each carrying 1(one) mark.

4. Further, due to rescheduling of the Preliminary Examination(Test) , the last date for submission of the name of intending candidates has also been extended .The list of the eligible candidates may be prepared Centre-wise strictly according to the proforma enclosed vide HQrs office circular of even No dated. 1.06.2012 and dispatched by name to **Shri J.K.Tharmatt , IDAS, Assistant CGDA (Admin) latest by 10th July, 2012 (Tuesday) positively. It is reiterated that all efforts should, be made to adhere to this date to enable us to hold the examination as per the time schedule and necessary action be initiated on top priority based on hoisting of the circular on CGDAs website.**
