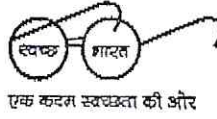

Dear Sir,

In continuation of this Department's D.O. letter of even number dated 28.11.2018 and 03.12.2018 regarding activities planned during Swachhta Pakhwada 2018, I would like to convey that Cabinet Secretary took a meeting on 04.12.2018 to review activities planned during Swachhta Pakhwada for MoD (1-15 December, 2018).

2. In the aforementioned meeting, Cabinet Secretary emphasized that in addition to the steps already being taken by DoD, the following may also be considered:-

- i. Defence establishments, particularly at the field level, may be encouraged to undertake activities not only within their campuses, but also in surrounding areas outside the campuses;
- ii. The Training Academies/Institutes may be advised to consider organizing workshops and seminars on related topics for wider dissemination of the swachhta message, with assistance from officials from the M/o Drinking Water and Sanitation;
- iii. Defence establishments at the field level shall encourage greater participation and competition based on performance in undertaking different swachhta activities during the ongoing Swachhta Pakhwada.


