OFFICE MEMORANDUM

Subject: - Filling up of one post of the Deputy Director (Finance) (Rs. 15600-39100+GP 6600) (corresponding scale as per seventh pay commission) in the National Tiger Conservation Authority-reg.

It is proposed to fill up one post of Deputy Director (Finance) in the National Tiger Conservation Authority (Rs. 15600-39100 plus Grade Pay Rs 6600/-) on deputation basis. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same/ or some other organization/department of the Central Government shall not ordinarily exceed three years The pay of the officer selected for the post will be regulated in accordance with Department of Personnel & Training (DoPT) O.M No. 2/29/91-Estt (Pay II) dated 05 January, 1994 as amended from time to time.

2. The Officer(s) of the Audit and Accounts Service, Civil Accounts Organization, Revenue Service, Railway Accounts Service possessing the following qualification and experience may apply for the appointment to the above post:

- (i) Holding analogous post or
- (ii) Accounts Officer in the Grade Pay of Rs. 5400/- (corresponding scale as per seventh pay commission) with five years regular service or
- (iii) Assistant Account Officer in the Grade Pay of Rs 4800/- (corresponding scale as per seventh pay commission) with six years regular service or
- (iv) Senior Accountant with Grade Pay of Rs 4600/- (corresponding scale as per seventh pay commission) with seven years regular service.

3. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of the receipt of the applications.

4. Applications of willing and eligible officers who can be spared immediately may be sent through proper channel along with(i) Bio-data (in triplicate) as in proforma at Annexure-I (ii) Photocopies of upto date CR dossiers of the officers for the last five years, duly attested (iii) Cadre Clearance (iv) Vigilance clearance/integrity Certificate and (v) Statement giving details of major or minor penalties imposed on the officer, if any to Shri Hemant Singh, Assistant Inspector General of forests(NTCA), so as to reach him by 29th July, 2023, positively.
