Subject: Transfer Establishment: DAD.

Reference: HQrs office circular even no. dated 14/11/2022 and 15/11/2022.

Kindly refer above HQ Circular vide which all DAD stations had been categorized for transfer/posting under three categories viz. Hard stations, North-Eastern regions including Sikkim and other stations. In continuation to this, a list of tenure stations is enclosed as Annexure with this letter which will be subset of "other stations" as notified vide circular dated 14/11/2022. Tenure in these stations will be for a period of three years and on repatriation after completion of prescribed tenure, such officers/staff will be accommodated by PCDA/CDA in one of their three choice stations within command. Posting (IN/OUT) in these tenure stations upto AAO level will be controlled by respective PCDA/CDA under their *jurisdiction as in case of "Other stations"* and *same rules will be applied as applicable to other stations* as brought out in Para 2 (3) of HQrs Circular dated 14/11/2022. These stations are distinct from hard stations.

2. However, all such individuals presently posted at hard and tenure stations as per HQrs circular no. 25012/AN-X/2014 dated 15/7/2014 will be governed by the earlier circular dated 28/3/2014 which was in vogue at that time & on their repatriation they will be accommodated to one of their choice stations on completion of their tenure.

3. In addition to this all PCsDA/CsDA may review the stations under their jurisdiction and if a need is felt based on merit to include/exclude some stations in the list of Hard and tenure stations, the same can be send by 10.01.2023 with justification for consideration of CGDA office.
